


PREFACE

This family is comprised of the descendants of Thoams
Warburton (circa 1756-1836) who was an infamous
madhouse keeper in East London. Despite his reputation for
the state of his institutions he left a will leaving considerable
wealth to his thee surviving children, the youngest of whom,
John, took over his madhouses and completely turned them
around. However John did not long survive his father, and
his son and grandson had even shorter lives so maybe the
wealth was accompanied by a curse.

First Generation

1. Thomas Warburton. Thomas was born abt 1756. Thomas died in Hackney, Middlesex, in 1836. He was buried in Hackney, St John of Jerusalem, Middlesex, on 20 Feb 1836.

Thomas became infamous as a madhouse keeper in East London. The full story can be read in **The Madhouse Keepers of Hackney** by Elaine Murphy, a chapter in volume 8 of Hackney History which can be seen at http://hackneyhistory.org/wp-content/uploads/2019/10/HH_Vol_8.pdf.

Thomas had 2 establishments, at Whitmore House near Hoxton, and at Bethnal Green. The treatment of the inmates of these establishments was appalling, and the subject of two Parliamentary Select Committee Enquiries in 1815 and 1827. However conditions don't seem to have improved until Thomas passed on the business to his son John.

Thomas's origins are unknown. One story is he was from the country, and formerly a butcher's apprentice. He worked his way up from gate porter at Whitmore House until he finally owned the establishment (possibly because his wife was the daughter of the previous owner). By the time he wrote his will in 1832 he had a considerable fortune to give to his three surviving children, Henry, Sarah and John. His residence was at Exmouth Place, Hackney and his will refers to properties around Mare Street. These, as well as his businesses, were left to his younger son John, who was a Doctor of Medicine, and who seems to have transformed his businesses.

Close to the location of his properties there is still today a Warburton Street and Warburton Road. Martello Hall, on the corner of Mare Street and Warburton Road, was known as The Warburton Arms until 1989.

Thomas was buried aged 79, suggesting he was born in 1756 or early 1757. I have found 3 baptisms on-line from that period. One in Bromborough, Cheshire was rapidly followed by a burial, and one in Bowdon, Cheshire is of a known member of the Warburton Village Clan.

This leaves a Thomas son of Thomas, who was baptised at Haslingden, St James on July 7th 1756. It is only recorded in the Bishop's Transcripts, mothers name is missing, and the abode is cut off in the image. It is possibly the last and late child of Thomas and Mary nee Warburton who married in 1730 and had several children baptised between 1737 and 1752. However, as one of those children was also a Thomas whose death hasn't been found, this Thomas is probably from an unknown family new to the area.

On 16 Oct 1783 when Thomas was 27, he married **Rose Hannah Dormer** in Hackney, St John of Jerusalem, Middlesex. Thomas and Rose were both 'of this parish'.

No death or burial record has been identified for Rose.

They had the following children:

 Thomas Warburton. Thomas was born in Hackney, Middlesex, in 1784. He was christened in Hackney, St John of Jerusalem, Middlesex, on 25 Jul 1784. Thomas died bef 1832.

Thomas's burial record has not been found. However his younger brother Henry was named as the eldest son in his father's will, implying he was deceased by the time it was written. However a Thomas Warburton witnessed the weddings of his siblings Henry in 1814 and Sarah in 1818. This could be his father, but it was more usual for witnesses to be siblings, so he may have lived until 1818.

ii. **Ann Warburton**. Ann was born in Hackney, Middlesex, in 1786. She was christened in Hackney, St John of Jerusalem, Middlesex, on 22 Jul 1786. Ann died in 1837. She was buried in Camden Town, Middlesex, on 1 Mar 1837.

Ann is not mentioned in her father's will, implying she was deceased by that time. However an Ann Dunstan from the workhouse was buried on March 1st 1837, in 'The Ground situate in Camden Town belonging to the parish of St Martin in the Fields' aged 50. This is an exact fit for Ann's birth.

On 5 Jun 1806 when Ann was 20, she married **John Dunstan** in Hackney, St John of Jerusalem, Middlesex. John was from the parish of St Peter le Poor in the City of London. Ann was 'from this parish', a spinster and minor. Witnesses were Mrs Warburton, Sarah Warburton, Thomas Dunstan and Louisa Potts. A license for the marriage of John Warburton and Ann Warburton was granted on May 31st 1806.

According to the Hackney History chapter on madhouse keepers, John was an apothecary who visited his father-in-law's madhouses.

- iii. **William Warburton**. William was born in Hackney, Middlesex, in 1788. He was christened in Hackney, St John of Jerusalem, Middlesex, on 21 Apr 1788. William died in Hackney, Middlesex, in 1789. He was buried in Hackney, St John of Jerusalem, Middlesex, on 24 Jan 1789.
- iv. Sarah Warburton. Sarah was born in Hackney, Middlesex, in 1790. She was

christened in Hackney, St John of Jerusalem, Middlesex, on 25 Feb 1790. Sarah died in Donhead, Wiltshire, in 1848.

Sarah's father's will stated:

"I give and devise unto my daughter Sarah, the wife of the Reverend William Dansey, Rector of Donhead, St Andrew in the county of Wilts ... but if she should die in my lifetime then unto the said William Dansey ... all the messuages, lands and Hereditamentsin the Parish of Donhead, St Andrew ... and the adjoining parish of Donhead, St Mary

"I give and bequeath to my said daughter Sarah....the sum of Seven Hundred pounds.....whereas I committed a grave error in [persuading] my said son in law William Dansey to quit the Medical Profession, to which he was bred, and by the practice of which he probably might have made a provision for his family, and in as much as the Rectory of Donhead, Saint Andrew aforesaid, the Advowson in fee of which I purchased and gave to the said William Dansey has deteriorated one third in value since I purchased ...

"to the said William Dansey and my said daughter SarahI give and bequeath to the Trustee or Trustees of the Settlement made previously to the marriage of the said William Dansey and Sarah his wife the sum of two thousand three hundred pounds three pound per cent Consolidated Annuities To be held by the Trustees and Trustee for the time being of the said Settlement ".

Sarah's death was registered in 2q 1848 Tisbury 8 317, aged 58.

On 28 May 1818 when Sarah was 28, she married **William Dansey** in Hackney, St John of Jerusalem, Middlesex. William was from Blandford, Dorset. They were married by Henry, Rector of Peatling, Leicestershire. William was born in Blandford Forum, Dorset, abt 1791. William died in 1856.

William was Rector of St Andrew, Donhead from 1820 to 1856. In the 1841 census William and Sarah were living at the Rectory House in Donhead, Wiltshire with 2 sons and 5 daughters. Following Sarah's death in 1848, William is present at the same address in the 1851 censuses with a second wife, also called Sarah, 2 daughters and a grandson. William is occupying 74 acres and employing 9 outdoor labourers and servants. Three servants (a cook, a housemaid and a nurse) are also living with them.

According to the British History Online entry for the parish of Donhead St Andrew "Thomas Warburton apparently bought the advowson and in 1820 presented his son-in-law William Dansey and conveyed the advowson to him. In 1853 Dansey sold it to R. B. Bourne, who in 1856 presented himself."

William's death was registered in 3q 1856 Weymouth 5a 183, aged 64.

2. Henry Warburton (*Thomas*¹). Henry was born in Hackney, Middlesex, in 1791. He was christened in Hackney, St John of Jerusalem, Middlesex, on 10 May 1791. Henry died in Sible Hedingham, Essex, in 1837. He was buried in Sible Hedingham, St Peter, Essex, on 14 Dec 1837.

Both Henry's sister Sarah, and his brother John were married by Henry, Rector of Peatling, Leicestershire at Hackney in 1818 and 1821 respectively. However the baptisms of Henry's children record he was the Curate in Chieveley, Berkshire in 1819, and 1821. It seems that either when Henry was working as a Curate in Chieverley, he had, or used the title of a Rector in Leicestershire to marry his siblings, or they were married by another family member called Henry.

Henry's father Thomas made complex provision in his will for Henry and his heirs to hold the living at Sible Headingham:

"I give and devise unto Thomas Poynder Esquire, Treasurer of Christ's Hospital, and Thomas Watson of Henrietta Street Cavendish Square in the said County of Middlesex, Doctor in Medicine, all that the perpetual advowson, right of patronage, and presentation of and to the Rectory and Parish Church of Sible Headingham in the County of Essex (of which my son the Reverend Henry Warburton is the present Incumbent)and also all those several pieces or parcels of freehold land lying near to the Rectory House, and which were purchased by me.... on part of which there has since erected a barn, stabling, and other outbuildings ... now in the occupation of my said son Henry Warburton....To hold the same ... for ever on the Trusts hereinafter expressed...that is to sayto permit and suffer my said son Henry Warburton ... to hold and enjoy the same so long as he shall continue the Incumbent of the said Rectory, and from and after the death or resignation of the said Henry Warburton....to present such son of my said son Henry Warburton to the said Rectory as the the said Thomas Poynder and Thomas Watson....the sum of twenty thousand pounds, three pounds per cent, Consolidated Annuities ... Upon Trust to pay the dividends, interest, and annual income of the same from time to time to become due during the natural life of my said son Henry Warburton... and from and after the decease of my said son Henry Warburton, then upon trust for the wife of the said Henry Warburton...if she shall so long continue his widow and unmarried".

On 14 Apr 1814 when Henry was 23, he married Emma Potts in Hackney, St John of

Jerusalem, Middlesex. Both were 'of this parish'. Thomas and Sarah Warburton were witnesses. Emma was born in Hackney, Middlesex, abt 1787. ■ Census for Canterbury, Kent, in 1851. Emma (60) is an independent widow living at 20 St Georges Place with Louisa (27), Margaret (26), Roseanne (24), Charlotte (22), Nona (19), and 4 servants. ■ Census for Folkestone, Kent, in 1861. Emma (69) is living independently in West Cliff Terrace with Emma (39), Louisa (38), Rose (30), Nona (26), and 3 servants. ■ Census for Folkestone, Kent, in 1871. Emma (80) is a widowed annuitant living at 43 Sandgate Road with Emma (48), Louisa (45), Nona (36), and 4 servants. ■ Census for Folkestone, Kent, in 1881. Emma (91) is a widow living at 43 Sandgate Road with Emma (60), Louisa A (58), Roseanna D (54), Nona (39), and 3 servants. Emma died in Folkestone, Kent, on 11 Dec 1882. She was buried in Folkestone, Cheriton Road Cemetery, Kent, on 16 Dec 1882.

Emma's death was registered in 4q 1882 Elham 2a 579, aged 95. The will of Emma Warburton of 43 Sandgate Road was proved by the Reverend Henry Warburton of Sible Hedingham, Essex, Clerk, and George Alexander Warburton of 37 Beaufort Gardens Middlesex, the sons and executors. Her personal estate was £823 10s. Her burial was recorded at St Mary and Eanswythe, and she was buried in Section 22 Plot C2926 of Cheriton Road Cemetery.

 Thomas James Warburton. Thomas James was born in Warfield, Berkshire, in 1817. He was christened in Warfield, Berkshire, on 15 May 1817. Thomas James died in Chieveley, Berkshire, in 1818. He was buried in Hackney, St John of Jerusalem, Middlesex, on 21 Aug 1818.

Thomas was baptised the son of Henry, a clerk, and Emma. He was buried aged 16 months, abode Clieveley, Berks.

ii. Emma Warburton. Emma was born in Chieveley, Berkshire, in 1819. She was christened in Chieveley, Berkshire, on 30 Dec 1819. She was christened in Sible Hedingham, St Peter, Essex, on 9 Dec 1823. ■ Census for Folkestone, Kent, in 1891. Minna (Emma 69), is living on her own means at 9 Copt Hall Gardens with Nona (48), niece Margaret (29) and 2 servants. ■ Census for Folkestone, Kent, in 1901. Minna (Emma 80), is living on her own means at 6 Bauverie Square with Nona (64), Charlotte D'Aeth (70) and 3 servants. Emma died aft 1891.

Emma was baptised the child of Henry and Emma at both Chieveley and Sible Headingham. At Chievely her father was a Curate. The date of the Sible Headingham baptism, coming 9 days before that of her brother Henry, suggests this is a re-baptism.

Emma has not been found in census, marriage or death records after 1891.

iii. Louisa Ann Warburton. Louisa Ann was born in Chieveley, Berkshire, in 1821. She was christened in Chieveley, Berkshire, on 13 Jul 1821. She was christened in Sible Hedingham, St Peter, Essex, on 16 Sep 1824. Louisa Ann died aft 1881.

Louisa was baptised the child of Henry and Emma, at both Chieveley and Sible Headingham. At Chieveley her father's occupation is Curate. The Sible Headingham baptism gave her age as at age 5 years, 2 months and 3 days. However this is a transcript; the image hasn't been viewed. It would put her birth only 5 months before the first baptism of her sister Emma. Curiously there are 3 years 2 months and 3 days between the two baptisms, suggesting Louisa was first baptised the day she was born, and the 5 years is an error and should be 3 years

Louisa has not been found in censuses, or in marriage or death registrations after 1881.

- iv. Margareta Warburton. Margareta was born in Sible Hedingham, Essex, in1822. She was christened in Sible Hedingham, St Peter, Essex, on 6 Sep 1822.
 - Margareta was baptised the child of Henry and Emma.
- 4 v. **Henry Warburton** (1823-1904)
 - vi. Rose Ann Warburton. Rose Ann was born in Sible Hedingham, Essex, in 1825. She was christened in Sible Hedingham, St Peter, Essex, on 30 Jul 1825. Census for Folkestone, Kent, in 1861. Rose (36) a clergyman's daughter, is visiting Annetta D'Aeth (32) a clergyman's daughter at 4 West Terrace. Rose Ann died in Dover, Kent, on 4 Jul 1894.

Rose was baptised the child of Henry and Emma. Her death was registered in 2q 1894 Dover 2a 531, aged 69. Probate for Rose Ann D of 30 Liverpool Road, spinster was granted to Henry Pigot Ireland Warburton, barrister-at-law and George John Coldham, solicitor. Her effects were £1,597 4s 4d.

- **5** vii. **William Warburton** (1826-1893)
 - viii. Charlotte Russell Warburton. Charlotte Russell was born in Sible Hedingham, Essex, in 1827. She was christened in Sible Hedingham, St Peter, Essex, on 16 Oct 1827. Census for Brighton, Sussex, in 1871. Charlott RH (40) is a widow living at 16 Clifton Road with Edward H H (9), sister Rosaine (Rose Ann, 41) and 2 servants. Charlotte Russell died in Folkestone, Kent, in 1909.

Charlotte was baptised the child of Henry, Rector of this Parish, and Emma. Her death was registered in 4q 1909 Elham 2a 639, aged 79.

In 1861 when Charlotte Russell was 34, she married **Cloudesly Hughes- D'Aeth**. The marriage was registered in 2q 1861 Elham 2a 1133. Cloudesly and Charlotte had a son Edward H. Cloudesly was born in Knowlton, Kent, abt 1830. Cloudesly died in Folkestone, Kent, on 3 Jun 1869.

Cloudesly's death was registered in 2q 1869 Elham 2a 505, aged 38. The will of the Reverend Cloudesly Hughes-D'Aeth late of Knowlton Courts, Kent Clerk Rector of the Parish Knowlton who died at 41 Sandgate Road, Folkstone was proved by oath of Charlotte Russell Hughes-D'Aeth of Knowlton Court, widow. His effects were under £1,500.

- 6 ix. George Alexander Warburton (1828-1891)
 - x. **Nona Warburton**. Nona was born in Sible Hedingham, Essex, in 1831. She was christened in Sible Hedingham, St Peter, Essex, on 1 May 1831. Nona died in

Folkestone, Kent, on 3 Dec 1903.

Nona was baptised the child of Henry, Rector of this Parish, and Emma. Nona's death was registered in 4q 1903 Elham 2a 639, aged 69. Probate for Nona of 83 Morehall Avenue, spinster was granted to Henry Pigot Ireland Warburton, barrister-at-law and George John Coldham, solicitor. Her effects were £2,260 0s 11d.

3. John Warburton (*Thomas*¹). John was born in Hackney, Middlesex, abt 1791. ■ Census for St Marylebone, Middlesex, in 1841. John (45) is an MD living at 23 Park Crescent, Cavendish Square with Thos (15), John A (15), Anne (13) and Marion (11). John died in Holborn, Middlesex, in 1845. He was buried in Highgate Cemetery, St James, Middlesex, on 7 Jun 1845.

John's father's will includes the following:

"And I give devise and bequeath to my said son John Warburton ... the freehold, Copyhold, and Leasehold manors, messuages, lands, tenements, and Hereditaments of in or to which. either in my own right or as an heir at Law, or otherwise howsoever I am seized, possessed, interested in, or in anywise entitled either as Mortgagee for my own benefit, or for the benefit of any other person or persons whomsoever or as a Trustee for any purposes whatsoever. To the end and intent that the said John Warburton may have a complete power of conveying and transferringand may also [be] enabled to perform the trusts [that] are held by me, and receive ... the sum or sums of money [that] shall become due to me on the security of the same Manors, messuages, lands, tenements, and Heredits.....and also such other sums of money ... as ... shall be receivable under or by virtue of the Trusts on which I hold any of the said Manors messuages lands tenements and Hereditaments.... I order and direct that all conveyances which shall be made, and all receipts and discharges for money due and to become due,which shall be given by the said John Warburton..... shall be as good, valid, and effectual to all intents and purposes as if the same had been given by me in my lifetime.

And I give devise and bequeathto my said son John Warburton all my said messuages, lands, and Heredits, called Exmouth Place, subject and without prejudice to the ...annuities [of] One Hundred pounds and fifty pounds hereinbefore charged thereon. And all other real Estates whatsoever whether of freehold, copyhold, Customary, or Leasehold tenure and situate in the several Parishes of Saint James, Westminster, Saint John, Hackney, and Saint Matthew, Bethnal Green all in the said County of Middlesex, or in any

other part of England which are my property and subject to my disposition or appointment. And all the Rest, Residue, and Remainder of my Goods and Chattels rights and credits, and the benefit of the business I now carry on in my Houses of Business in the parish of Saint Matthew, Bethnal Green aforesaid, and Whitmore House in the Parish of Saint John, Hackney, and also all my money, stocks, funds, and securities, personal Estate and Effects whatsoever, and wheresoever or of what nature kind or quality soever. "

John was also appointed executor, and he proved the will on March 10th 1836.

The Hackney History refers to John as follows:

"John Warburton was in his 30s when he took over his inheritance, already making a name for himself as physician to St Luke's. He moved in highly respectable circles within his profession, having married the daughter of Abernethy, the flamboyant Barts surgeon. Over the next 15 years, the new national Commissioners in Lunacy believed, Bethnal Green Asylum was transformed into a most remarkable institution, the best in the metropolis. So impressed were they with the transformation that a whole chapter was given over in their Special Report of 1847 to documenting the process of change."

As John only lived 9 years after his father's death, and was already 44 when his father died, it would seem he may have taken over the running of the madhouses before his father died.

John of Park Crescent, Marylebone was buried aged 54. His death was registered in 2q 1845 Marylebone 1 119, aged 52. This is incorrect based on his date of birth.

On 5 Apr 1821 when John was 30, he married **Anne Abernethy** in Holborn, St Andrew, Middlesex. John was from the Parish of St James, Westminster. Anne was a spinster, and minor from 'this parish'. They were married by license with the consent of John Abernethy Esquire the natural and lawful father of the said minor. They were married by Henry Warburton Rector of Peatling, Leicestershire. Witnesses were John Abernethy, Thomas Warburton, and Elizabeth Abernethy. Anne was born in Bedford Row, Middlesex, on 23 Feb 1801. She was christened in Holborn, St Andrew, Middlesex, on 20 Mar 1801. Anne died in 1867. She was buried in Hackney, St John of Jerusalem, Middlesex, on 21 May 1867.

The Hackney History chapter on madhouses describes Anne's father as a flamboyant Barts surgeon. She was from Grove Street when she was buried aged 66. Her death was registered in 2q 1867 Hackney 1b 266, aged 66.

Second Generation

They had the following children:

 Thomas Warburton. Thomas was born in Westminster, London, on 17 Jan 1822. He was christened in Piccadilly, St James, Westminster, on 14 Mar 1822. Thomas died in Feb 1846. He was buried in Highgate Cemetery, St James, Middlesex, on 2 Feb 1846.

Thomas was baptised the son of John (a Physician) and Anne of Clifford Street. He was buried as the son of John and Anne. His death was registered in 1q 1846 Marylebone 1 131, aged 24.

- 7 ii. John Abernethy Warburton (1825-1850)
 - iii. **Anne Warburton**. Anne was born in Westminster, London, on 19 Dec 1827. She was christened in Piccadilly, St James, Westminster, on 30 Jan 1828.

Anne was baptised the daughter of John (MD) and Anne of Clifford Street.

iv. **Marion Warburton**. Marion was born on 30 Apr 1830. She was christened in Piccadilly, St James, Westminster, on 14 Jun 1830.

Marion was baptised the son of John (MD) and Anne of Clifford Street. No records for her have been found after 1861.

On 30 Apr 1850 when Marion was 20, she married **William Cother** in Shanklin, Isle of White, Hampshire. William and Marion were still childless in the 1861 census. William was born in Gloucester, Gloucestershire, abt 1812. William died in 1869.

William's death was probably that registered in 4q 1869 St George Hanover Square 1a 206, aged 56.

4. Henry Warburton (*Henry*², *Thomas*¹). Henry was born in Sible Hedingham, Essex, in 1823. He was christened in Sible Hedingham, St Peter, Essex, on 18 Dec 1823. ■ Census for Sible Hedingham, Essex, in 1851. Henry (27) is the Rector of Sible Headingham living in Church Street with his sister Emma (30, and born in Chieveley, Berkshire), and 4 servants. ■ Census for Sible Hedingham, Essex, in 1861. Henry (36) is the Rector of Sible Hedingham living in the Rectory House, Church Street with Agnes (27), sister Charlotte R (30), visitor Cloudesley H D'Aeth Curate of Sible Headingham, Henry PJ (7), Welbey R (3), William GA (1), and 6 servants. ■ Census for Sible Hedingham, Essex, in 1871. Henry (46) is the Rector of Sible Headingham living in the Church Street Rectory with Agnes (37), Agnes M (5), a butler and 4 servants. ■ Census for Sible Hedingham, Essex, in 1881. Henry (55) is the Rector of Sible Headingham living at the Rectory with Agnes (46), and 4 servants. ■ Census for Sible Hedingham, Essex, in 1891. Henry (66) is a clerk in Holy Orders (Rector) living at the Rectory with Agnes (46), Agnes M (25), and 4 servants. ■ Census for Sible Hedingham, Essex, in 1901. Henry (77) is Rector of Sible Headingham living at the Rectory with Agnes (68), Welby R (43) Curate of Sible Headingham, and 4 servants. Henry died in Sible Hedingham, Essex, in 1904.

Henry was baptised the child of Henry and Emma. His death was registered in 3q 1904 Halstead 4a 510, aged 80.

On 8 Jun 1852 when Henry was 29, he married **Agnes Ireland** in St Marylebone, Trinity Church, Middlesex. The Reverend Henry was a cleric of full age from Sible Headingham in Essex, father Henry, a cleric, deceased. Agnes was a minor from Trinity District, father Thomas James Esquire. One of the witnesses looks like Mrs (or Miss) Agnes (or Anne) Warburton. Agnes was born in Ousden, Suffolk, abt 1833. ■ Census for Sible Hedingham, Essex, in 1911. Agnes (74) is living at the Rectory with her son Welby. She had 4 children, 3 still living. Agnes died in Sible Hedingham, Essex, in 1914.

Henry Pigot Ireland (57) is a Barrister at Law living at 13 Ashburnham Mansions, Ashburnham Road (floor of 6 rooms) with Virna Lyselma (52), and a servant. Henry and Virna had been married 21 years but had no children. Henry Pigot Ireland died in Chelsea, Middlesex, on 21 Feb 1921.

Henry's birth was registered in 4q 1853 Halstead 4a 251, mother's maiden name Ireland. He was baptised the son of Henry and Agnes. His death was registered in 1q 1921 Chelsea 1a 523, aged 67.

Probate for Henry Pigot Ireland Warburton of 13 Ashburnham Mansions, 1 Kings Bench Walk, Temple, and of Hedringham, Molesey, Surrey was granted to Richard Osborn cadd, solicitor, Geoffrey Clifford Tyndale, barrister at law, and Bessie Mary Harris, widow. His effects were £8,821 10s 6d.

In 1890 when Henry Pigot Ireland was 37, he married **Virna Lyselma Bicknell** in Paddington, London. The marriage was registered in 1q 1890 Paddington 1a 28. Virna Lyselma was born in Denmark Hill, Surrey, abt 1858. Virna Lyselma died in Queens Gate, Middlesex, on 17 Dec 1921.

Welby Russell Warburton (53) is a clergyman (Established Church) living at Sible Headingham Rectory (23 rooms) with his widowed mother Agnes (74) and 4 servants. Welby Russell died in Sible Hedingham, Essex, on 5 Sep 1918.

Welby's birth was registered in 3q 1857 Halstead 4a 277, mother's maiden name Ireland. He was baptised the son of Henry, a clerk, and Agnes.

His death was registered in 3q 1918 Halstead 4a 769, aged 61. Probate for the Reverend Welby Russell of Sible Hedingham Rectory was granted to Joshua Owen Steed, and Francis George Steed, solicitors. His effects were £21,020 18s 8d. He never married.

iii. William George Alexander Warburton. William George Alexander was born in Sible Hedingham, Essex, in 1859. He was christened in Sible Hedingham, St Peter, Essex, on 14 Jun 1859. ■ Census for Springfield, Essex, in 1871. William (11) is a pupil at school.

William's birth was registered in 2q 1859 Halstead 4a 319, mother's maiden name Ireland. He was baptised the son of Henry, a clerk in Holy Orders, and Agnes.

William has not been found in censuses after 1871, and no marriage or death registration has been identified. However since his sister Agnes died in 1892, he must be one of the three children his mother declares still living in 1911, suggesting he was living or serving abroad.

William is also listed under Gloucester Vessels as not being on board. ■ Census for Dedham, Essex, in 1891. Also present are her brother Arthur (15), children Thomas F (21 months), and Clara (10 months), 3 servants and 2 visitors. Clara died in Regents Park, Middlesex, on 18 Nov 1887.



Thomas F (13) and Mabel C (11) are living with their grandmother Ashfield Harries (48) a widow living on her own means at 22 Green Park, Walcott with her daughter, and 3 servants. ■ Census for Bradwell, Buckinghamshire, in 1901. Thos F (23) and Mabel C (21) are living on their own means with their grandmother Ashfield Harries (67) a widow living on her own means, at Bradwell House, with 4 servants.
