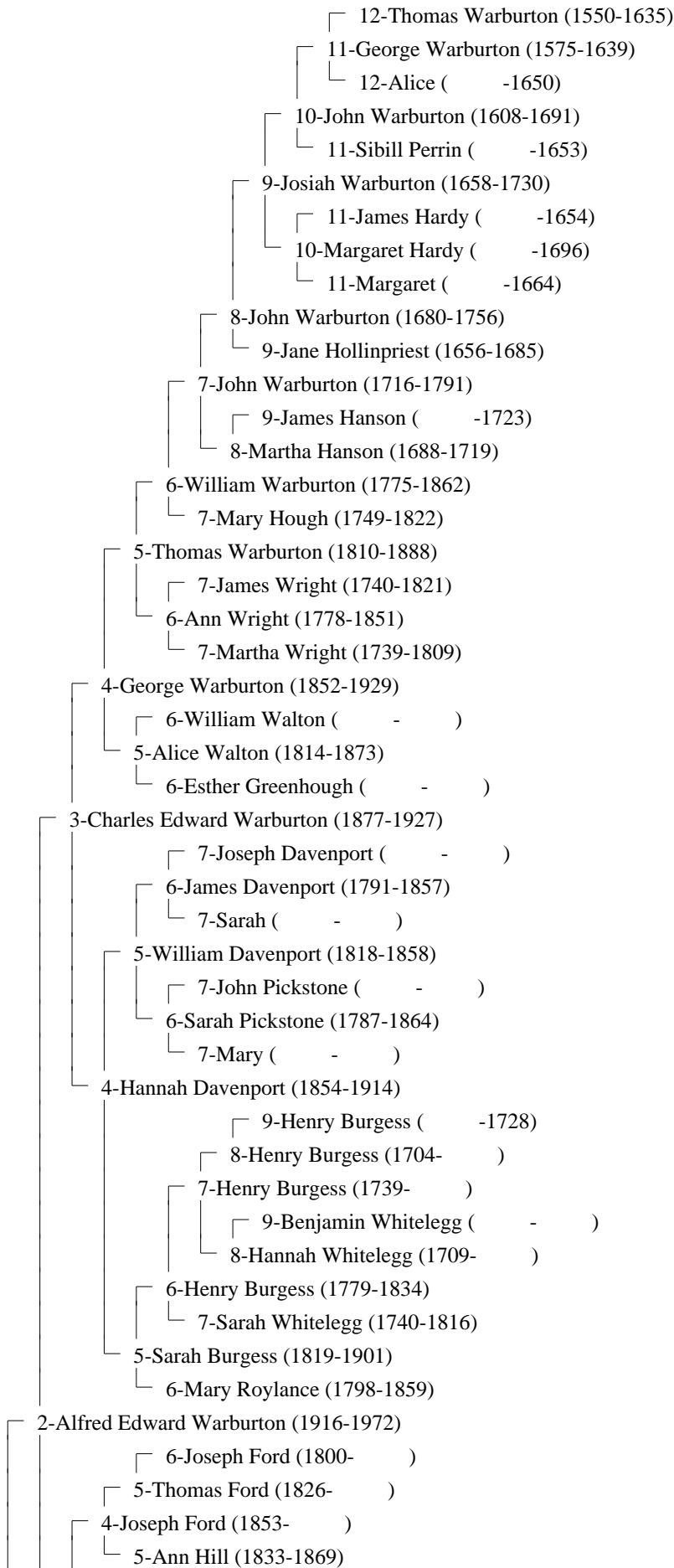

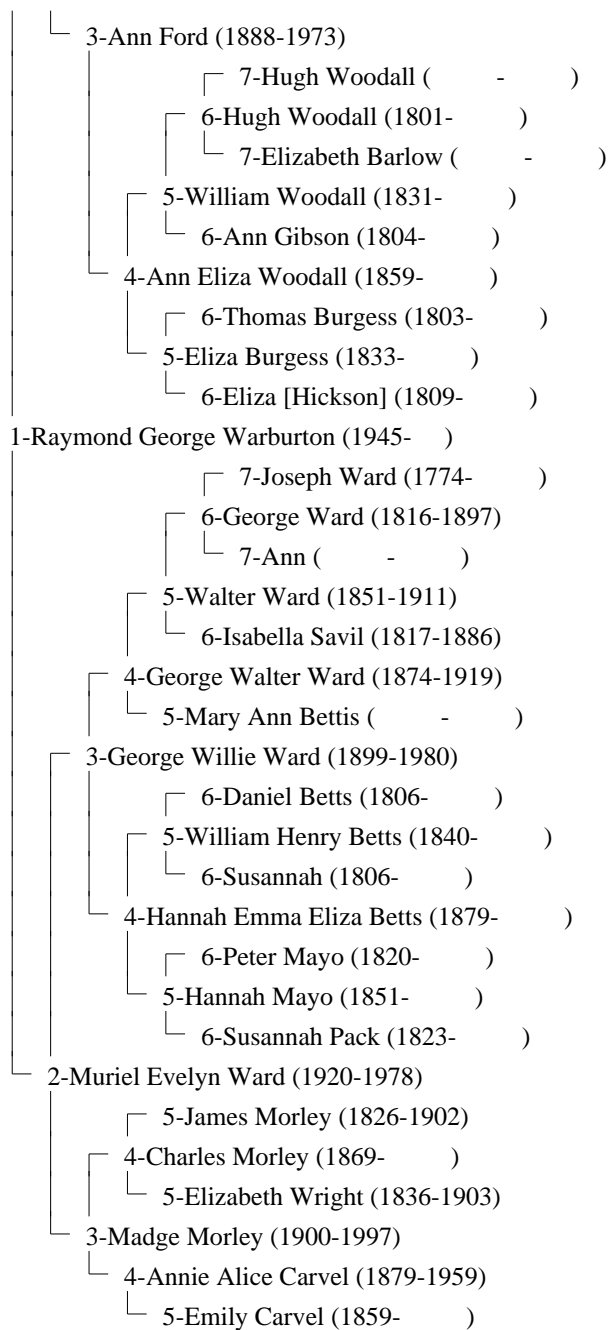

First Generation

1. **Raymond George Warburton**, son of **Alfred Edward Warburton** and **Muriel Evelyn Ward**, was born on 12 Aug 1945 in Altrincham, Cheshire.

Raymond married **Janet Hylda Warburton** on 12 Apr 1969 in Chesterfield, Derbyshire. Janet was born on 2 Nov 1946 in Chesterfield, Derbyshire.

Second Generation (Parents)

2. **Alfred Edward Warburton**, son of **Charles Edward Warburton** and **Ann Ford**, was born on 12 Mar 1916 in Altrincham, Cheshire and died on 5 Nov 1972 in Timperley, Cheshire aged 56.

Noted events in his life were:

- Legacy: 24 Feb 1928. Probate granted on his father's will which bequeathed him £100.

Alfred married **Muriel Evelyn Ward** in 1944 in Altrincham, Cheshire. Muriel was born on 15 Jun 1920 in Altrincham, Cheshire and died on 25 May 1978 in Timperley, Cheshire aged 57.

Children from this marriage were:

- 1 i. **Raymond George Warburton** (born on 12 Aug 1945 in Altrincham, Cheshire)
- ii. **Cheryl Lynn Warburton** was born on 3 Jun 1948 in Altrincham, Cheshire.
- iii. **Gail Lesley Warburton** was born on 6 Dec 1952 in Altrincham, Cheshire.

3. **Muriel Evelyn Ward**, daughter of **George Willie Ward** and **Madge Morley**, was born on 15 Jun 1920 in Altrincham, Cheshire and died on 25 May 1978 in Timperley, Cheshire aged 57.

Muriel married **Alfred Edward Warburton** in 1944 in Altrincham, Cheshire. Alfred was born on 12 Mar 1916 in Altrincham, Cheshire and died on 5 Nov 1972 in Timperley, Cheshire aged 56.

Third Generation (Grandparents)

4. **Charles Edward Warburton**, son of **George Warburton** and **Hannah Davenport**, was born in 1877 in Altrincham, Cheshire, died on 1 Nov 1927 in Bridgewater Canal, Sale, Cheshire aged 50, and was buried on 4 Nov 1927 in Altrincham And Hale Cemetery.

General Notes: Charles's birth was registered 1q 1877 (Altrincham 8a 197), and his death in 4q 1927 (Bucklow 8a 218). His address at the time of his death was 1 George Street, Altrincham. Cause of death was suicide by drowning in the canal while of unsound mind.

An Inquest was held on 3rd November, and reported in the Altrincham Guardian of November 11th. He was last seen on Friday 29th October taking a tramcar to Sale where, instead of walking to his brother Alan's house in Barkers Lane he turned down Urban Road towards the canal. His body was discovered by a boatman on Tuesday 1st November near Egerton Street, Sale. The verdict was temporary insanity resulting from neurasthenia, which in turn was caused by an unfounded fear that he had cancer.

A funeral service was held at 'the house' prior to interment in Altrincham Cemetery.

Noted events in his life were:

- He appeared on the census in 1891 in Altrincham, Cheshire. Charles, aged 14, is an office boy living with his parents and family at 20 Stamford Road.
- He appeared on the census in 1901 in Altrincham, Cheshire. Charles, aged 24, is an upholsterer living with his parents and family at 27 Stamford Road.
- He appeared on the census in 1911 in Altrincham, Cheshire. Charles, aged 34, is an upholsterer living with his parents and family at 23 Sandiway Road.
- He signed a will on 18 Mar 1927. Charles bequeathed £100 each to his children and the rest of his estate to his wife.

Charles married **Ann Ford** in 1914 in Altrincham, St George, Cheshire. Ann was born on 11 Feb 1888 in Mere, Cheshire and died on 23 Sep 1973 in The Mount Nursing Home, Sale, Cheshire aged 85.

Marriage Notes: The marriage was registered in 1q 1914 (Bucklow 8a 253; C BMD CE3/3/18).

Children from this marriage were:

- 2 i. **Alfred Edward Warburton** (born on 12 Mar 1916 in Altrincham, Cheshire - died on 5 Nov 1972 in

- Timperley, Cheshire)
- ii. **Edith Adeline Warburton** was born in 1914 in Altrincham, Cheshire and died in 1983 in Timperley, Cheshire aged 69.

5. Ann Ford, daughter of **Joseph Ford** and **Ann Eliza Woodall**, was born on 11 Feb 1888 in Mere, Cheshire and died on 23 Sep 1973 in The Mount Nursing Home, Sale, Cheshire aged 85.

General Notes: Ann's birth was registered in 1q 1888 Altrincham 8a 201 (C BMD KNU/24/610. Her death was registered in 3q 1973 Bucklow 10a 318.

Noted events in her life were:

- She appeared on the census in 1911 in Timperley, Cheshire. Ann is probably the Annie Ford (21) a domestic servant to Arthur and Ann Mallinson at Heather Lea, Broomfield Avenue.

Ann married **Charles Edward Warburton** in 1914 in Altrincham, St George, Cheshire. Charles was born in 1877 in Altrincham, Cheshire, died on 1 Nov 1927 in Bridgewater Canal, Sale, Cheshire aged 50, and was buried on 4 Nov 1927 in Altrincham And Hale Cemetery.

6. George Willie Ward, son of **George Walter Ward** and **Hannah Emma Eliza Betts**, was born on 26 Feb 1899 in Leyton, Essex and died on 29 Mar 1980 in Withington Hospital aged 81.

General Notes: George, my grandfather, ran away from home and joined the army, lying about his age. He fought in WW1, was wounded, and met my grandmother, who was a nurse, whilst convalescing in Bowdon. As far as I am aware he had no further contact with his family.

George was born at 49 Harrow Road, Leytonstone.

George married **Madge Morley** on 22 Dec 1919 in Altrincham, St John, Cheshire. Madge was born on 8 May 1900 in Northampton, Northamptonshire and died in 1997 aged 97.

Marriage Notes: Marriage registration 4q 1919 Bucklow 8a 413.

Children from this marriage were:

- i. **Muriel Evelyn Ward** (born on 15 Jun 1920 in Altrincham, Cheshire - died on 25 May 1978 in Timperley, Cheshire)
 - ii. **Joyce Ward** was born about 1928.

7. Madge Morley, daughter of **Charles Morley** and **Annie Alice Carvel**, was born on 8 May 1900 in Northampton, Northamptonshire and died in 1997 aged 97.

General Notes: Madge's death was registered in 2q 1997 Garstang 27b 145.

Madge married **George Willie Ward** on 22 Dec 1919 in Altrincham, St John, Cheshire. George was born on 26 Feb 1899 in Leyton, Essex and died on 29 Mar 1980 in Withington Hospital aged 81.

Fourth Generation (Great-Grandparents)

8. George Warburton, son of **Thomas Warburton** and **Alice Walton**, was born in 1852 in Flixton, Lancashire, died on 5 Apr 1929 in Altrincham, Cheshire aged 77, and was buried on 8 Apr 1929 in Bowdon, St Mary, Cheshire.

General Notes: George's birth was registered in 1q 1852 (Barton 8c 453). His grave is 2894. He is buried with his parents Thomas and Alice, brother William, and his wife Hannah, and sister-in-law Sarah Davenport. His age is recorded as 77 years.

Sometime after 1901 George and his family moved to Sunnybank, Grosvenor Road, Altrincham, and later to Ardene, a large house at 23 Sandiway Road, where they appear on the 1911 census, and where George was living at the time of his death. Ardene was demolished in the 1930's, to make way for, amongst other things, the Garrick Theatre. George was at one time secretary of the Joiner's Association. He was a strong Liberal and his religion was described as 'Chapel' (Kenneth Shawcross).

His death registration is 2q 1929 Bucklow 8a 186.

Noted events in his life were:

- He appeared on the census in 1871 in Altrincham, Cheshire. George, aged 19, is a joiner's apprentice living with his parents at 12 John Street.
- He appeared on the census in 1881 in Altrincham, Cheshire. George, aged 29, is a joiner living at 20 Meadowbank,

Stamford Road with his wife Hannah (27) a dressmaker, and children Frederick (5), Charles E (4), George A (3), and Thomas H (3 months). Also present is mother-in-law Sarah Davenport (61).

- He appeared on the census in 1891 in Altrincham, Cheshire. George, aged 39, is a house joiner living at 20 Stamford Road with his wife Hannah (37) a dressmaker, and children Frederick (15) a warehouse youth, Charles E (14) an office boy, George A (12), Thomas H (10), Herbert (8), and Alan W (3). Also present is mother-in-law Sarah Davenport (72).
- He appeared on the census in 1901 in Altrincham, Cheshire. George, aged 49, is a joiner (staircase hand?) living at 27 Stamford Road with his wife Hannah (47), and children Frederick (25) a salesman (cotton linings), Charles E (24) an upholsterer, George A (22) a printer compositor, Herbert (18) an apprentice wholesale draper, Alan W (13) an office boy (estate agent), and Edith Alice (9). Also present is sister-in-law Sarah Davenport (44).
- He appeared on the census in 1911 in Altrincham, Cheshire. George, aged 59, is a joiner living at 23 Sandiway Road with Hannah (58), Charles E (34) an upholsterer, Herbert (28) a salesman (wholesale draper), Alan Wm (23) a commercial traveller (wholesale draper), Edith Alice (19) a typist at a photographic manufacturers, and sister-in-law Sarah Davenport (55). George and hannah had been married 37 years and had 7 children, all living.

George married **Hannah Davenport** on 19 Aug 1874 in Altrincham, St George, Cheshire. Hannah was born in 1854 in Altrincham, Cheshire, died on 24 Jun 1914 in Altrincham, Cheshire aged 60, and was buried on 27 Jun 1914 in Bowdon, St Mary, Cheshire.

Marriage Notes: The parish record describes George as a Joiner at John St., Altrincham, aged 22. His father is Thomas, a farmer. Hannah is 21 from Meadow Bank, Altrincham. Her father is William, a miller, deceased. The marriage is registered in 3q 1874 (Altrincham 8a 175).

Children from this marriage were:

- i. **Frederick Warburton** was born in 1876 in Altrincham, Cheshire, died on 19 Oct 1954 in Altrincham, Cheshire aged 78, and was buried in 1954 in Altrincham And Hale Cemetery.
- 4 ii. **Charles Edward Warburton** (born in 1877 in Altrincham, Cheshire - died on 1 Nov 1927 in Bridgewater Canal, Sale, Cheshire)
- iii. **George Arthur Warburton** was born in 1878 in Altrincham, Cheshire, died on 26 Nov 1934 aged 56, and was buried in 1934 in Altrincham And Hale Cemetery.
- iv. **Thomas Harry Warburton** was born in 1880 in Altrincham, Cheshire and died about 1960 aged about 80.
- v. **Herbert Warburton** was born in 1883 in Altrincham, Cheshire and died in 1959 in Altrincham, Cheshire aged 76.
- vi. **Alan William Warburton** was born in 1888 in Altrincham, Cheshire and died after 1920.
- vii. **Edith Alice Warburton** was born on 23 Sep 1891 in Altrincham, Cheshire and died on 22 May 1952 aged 60.

9. Hannah Davenport, daughter of **William Davenport** and **Sarah Burgess**, was born in 1854 in Altrincham, Cheshire, died on 24 Jun 1914 in Altrincham, Cheshire aged 60, and was buried on 27 Jun 1914 in Bowdon, St Mary, Cheshire.

General Notes: Hannah's birth was registered in 1q 1854 Altrincham 8a 173.

Hannah's death certificate says she died at 23 Sandiway Road from malignant disease of the lung, and exhaustion. George, described as a joiner (journeyman), was present at her death and was the informant. Hannah's grave is 2894. She is buried with her parents-in-law Thomas and Alice, brother-in-law William, her husband George, and her sister Sarah Davenport. Her age is recorded as 61 years.

Hannah married **George Warburton** on 19 Aug 1874 in Altrincham, St George, Cheshire. George was born in 1852 in Flixton, Lancashire, died on 5 Apr 1929 in Altrincham, Cheshire aged 77, and was buried on 8 Apr 1929 in Bowdon, St Mary, Cheshire.

10. Joseph Ford, son of **Thomas Ford** and **Ann Hill**, was born on 25 May 1853 in Tabley, Cheshire.

General Notes: Information on Joseph and his ancestors is based on the tree placed on Genes Reunited by Amanda Wood, which I will attempt to expand with my own research in due course.

Noted events in his life were:

- He appeared on the census in 1881 in Mere, Cheshire. Joseph (27) is a farmer of 54 1/2 acres at Hulse heath farm, employing 1 man. He is living with Ann E (22), Sarah Ann (5 months), Margaret S Woodhall sister-in-law, and Joseph Stead (16) a servant.
- He appeared on the census in 1891 in Mere, Cheshire. Joseph (37) is a farmer living at Hulse Heath with Ann E (32), Sarah A (10), Thomas (8), Mary (7), Joseph (5), Ann (3), Susannah (1), and Hannah E Woodall (19) a visitor.
- He appeared on the census in 1901 in Mere, Cheshire. Joseph (47) is a farmer living at Hulse Heath with Ann E (42), Mary (17), Joseph (15), Ann (13), Susannah (11), Benjamin (8), William (6), Alfred (3), and Sarah E Woodall, sister-in-law.
- He appeared on the census in 1911 in Mere, Cheshire. Joseph (57) is a farmer living at Hulse Heath with Ann Eliza (52),

Joseph (25), Susannah (21), Benjamin (18), William (16), and Alfred (13).

Joseph married **Ann Eliza Woodall** in 1880 in Great Budworth, St Mary, Cheshire. Ann was born in 1859 in Mobberley, Cheshire.

Marriage Notes: The marriage was registered in 1q 1880 Runcorn 8a 255 (C BMD Cheshire Central 126/4/372).

Children from this marriage were:

- i. **Sarah A Ford** was born on 10 Oct 1880 in Mere, Cheshire and died after 1901.
- ii. **Thomas Ford** was born on 16 Apr 1882 in Mere, Cheshire and died after 1950.
- iii. **Mary Ford** was born on 28 Jun 1883 in Mere, Cheshire and died in 1952 aged 69.
- iv. **Joseph Ford** was born on 9 Sep 1885 in Mere, Cheshire and died after 1927.
- 5 v. **Ann Ford** (born on 11 Feb 1888 in Mere, Cheshire - died on 23 Sep 1973 in The Mount Nursing Home, Sale, Cheshire)
- vi. **Susannah Ford** was born on 22 Sep 1889 in Mere, Cheshire and died after 1927.
- vii. **Benjamin Ford** was born on 24 Apr 1892 in Mere, Cheshire and died after 1911.
- viii. **William Ford** was born on 3 Nov 1894 in Mere, Cheshire and died after 1927.
- ix. **Alfred Ford** was born on 29 May 1897 in Mere, Cheshire and died after 1927.
- x. **Hugh Ford** was born on 3 Feb 1900 in Mere, Cheshire and died in 1900.

11. Ann Eliza Woodall, daughter of **William Woodall** and **Eliza Burgess**, was born in 1859 in Mobberley, Cheshire.

General Notes: Information on Ann and her ancestors is based on the tree placed on Genes Reunited by Amanda Wood, which I will attempt to expand with my own research in due course.

Ann married **Joseph Ford** in 1880 in Great Budworth, St Mary, Cheshire. Joseph was born on 25 May 1853 in Tabley, Cheshire.

12. George Walter Ward, son of **Walter Ward** and **Mary Ann Bettis**, was born on 22 Dec 1874 in Stratford, Essex and died after 1919.

General Notes: George's census age puts his birth between April 1874 and March 1875. This is before his father's marriage to Susan Bowers so he is a son of his first marriage. The only birth of a George Walter registered in the appropriate period is 1q 1875 Pancras 1b 191, but his father's name is William John so he is discounted.

There is a George William born 21 December 1874 at 13 Waddington Street, Stratford, father George Walter a labourer, mother Mary Ann, formerly Bettis. The time, place and father's name are correct. George Walter's birthplace is given as Stratford on the 1881 census and there is no evidence of George William in that census.

However there is no registration of a marriage between a Ward and Bettis in the 20 years before George's birth (or a Betts in the London area), so it appears the marriage wasn't registered. Although many deaths of a Mary Ann Ward are registered between 1875 and 1879, the only one in West Ham was a little old and married to William. There is one in Whitechapel in 2q 1877 aged 27 that hasn't been checked. Church records have not yet been checked.

Noted events in his life were:

- He appeared on the census in 1891 in Leyton, Essex. George (16), born in Stratford, is lodging at 2 Wood Street.
- He appeared on the census in 1901 in Grove Green, Leyton, Essex. George (26) is a labourer for GER, living at 38 Ashville Rd. with Emma (21), Hannah (5), and George W (2).
- He appeared on the census in 1911 in Harrow Green, Leytonstone, Essex. George (36) is a platelayer for G E Railway, living at 2 Granville Street with Emma (31), Hannah (15) who worked in a chocolate factory, George (12), Arthur (9), David (7), and Elsie (2). Another son Frederick was recorded with a note he had died.

George married **Hannah Emma Eliza Betts** on 25 Dec 1895 in Leytonstone, St Margarets, Essex. Hannah was born on 11 Dec 1879 in Stepney, London.

Marriage Notes: Marriage registration 4q 1895 West Ham 4a 138. At the time of the marriage George was living at 1 Lancaster Road, Leytonstone, father George Walter Ward, labourer. Hannah was at 8 Argyle Street, father William, labourer.

Children from this marriage were:

- i. **Hannah Annie E Ward** was born in 1896 in Leytonstone, Essex.
- 6 ii. **George Willie Ward** (born on 26 Feb 1899 in Leyton, Essex - died on 29 Mar 1980 in Withington Hospital)
- iii. **Arthur Ward** was born in 1901 in Leytonstone, Essex.
- iv. **David William R Ward** was born in 1903 in Leytonstone, Essex.

13. Hannah Emma Eliza Betts, daughter of **William Henry Betts** and **Hannah Mayo**, was born on 11 Dec 1879 in Stepney, London.

General Notes: Hannah's birth was registered in 1q 1880 Stepney 1c 479. She was born at 1 Providence Place, Halley Street, Limehouse, father William Henry a Deal Poster, mother Hannah nee Mayo.

Hannah married **George Walter Ward** on 25 Dec 1895 in Leytonstone, St Margarets, Essex. George was born on 22 Dec 1874 in Stratford, Essex and died after 1919.

14. Charles Morley, son of **James Morley** and **Elizabeth Wright**, was born in 1869 in Northampton, Northamptonshire.

Noted events in his life were:

- He appeared on the census in 1901 in Northampton, Northamptonshire. Charles (32) is a foreman, welt room, [w]ool trade, living at 5 Purser Rd. with Annie (21), Madge (10 months), and mother-in-law Emily Maule, a laundress.
- He appeared on the census in 1911 in Hale, Cheshire. Charles (43) is a bootmaker, living at 54 Hale Rd. with Annie (31), Madge (10), Percy (7) and mother-in-law Emily Maule (52), a widow.

Charles married **Annie Alice Carvel** in 1899. Annie was born on 13 Aug 1879 in Greens Norton, Northants and died in 1959 in Altrincham, Cheshire aged 80.

Marriage Notes: The marriage was registered in 4q 1899 at Northampton (3b 159). Annie is called Ann Carvell.

Children from this marriage were:

- 7 i. **Madge Morley** (born on 8 May 1900 in Northampton, Northamptonshire - died in 1997)
- ii. **Percy Morley** was born about 1903 in Dublin, Ireland and died in 1918 aged about 15.

15. Annie Alice Carvel, daughter of **Unknown** and **Emily Carvel**, was born on 13 Aug 1879 in Greens Norton, Northants and died in 1959 in Altrincham, Cheshire aged 80.

General Notes: Death registered in 3q 1959 (Bucklow 10a 81). She is called Annie A, aged 78, which is about 2 years too young.

Annie married **Charles Morley** in 1899. Charles was born in 1869 in Northampton, Northamptonshire.

Fifth Generation (Great Great-Grandparents)

16. Thomas Warburton, son of **William Warburton** and **Ann Wright**, was born on 2 Dec 1810 in Hale Barns, Cheshire, was christened on 30 Dec 1810 in Ringway, St Mary And All Saints, Cheshire, died on 15 Jul 1888 in Altrincham, Cheshire aged 77, and was buried on 18 Jul 1888 in Bowdon, St Mary, Cheshire.

General Notes: The evidence that this Thomas is the Thomas subsequently living in Flixton is that Thomas's son William aged 10 of Flixton is staying with his uncle William (born 1803) son of William Snr in 1861. William (1803) is staying with his father in 1841, and brother Josiah in 1851.

His parish baptism record states his parents are of Hale. His death is registered in 3q 1888 (Altrincham 8a 102, CBMD ref ALT/39/38). His grave is 2894. His was buried with his wife Alice, sons William and George, and George's wife Hannah, and sister-in-law Sarah Davenport. His age is given as 77 years.

Noted events in his life were:

- He appeared on the census in 1841 in Flixton, Lancashire. Thomas is an Inn Keeper aged 30, living with wife Alice (27), Mary (6 weeks), and Ellen Booth (13) who may be a servant.
- He appeared on the census in 1851 in Flixton, Lancashire. Thomas, aged 40, is an Inn Keeper at the Gray Hound Inn. His place of birth is Hale on this and all subsequent censuses. Also present are Alice (36), Ellen (8), Alice (7), Thomas (5) Ann (2), William (1), and niece Elizabeth Millatt (13), the daughter of Alice's sister Martha.
- He appeared on the census in 1861 in Flixton, Lancashire. Thomas, aged 50, is a farmer of 35 acres in Flixton village, employing 1 man. Also present are Alice (46), Alice (17) who is a dressmaker, Thomas (15), Ann (12), George (9), Esther (6), Wright (4), and servant James Fletcher (21) who is a carter.
- He appeared on the census in 1871 in Altrincham, Cheshire. Thomas, aged 60, is a carter living at 12 John Street with Alice (56), George (19) a joiner's apprentice, Esther (16) a dressmaker, and Wright (14) an errand boy.
- He appeared on the census in 1881 in Altrincham, Cheshire. Now a widower Thomas is living at 12 Pownall St with his daughter Alice Davies, her husband and five children. He was head of the family and a retired farmer.

Ancestors of Raymond George Warburton

Thomas married **Alice Walton** on 12 Sep 1838 in Bowdon, St Mary, Cheshire. Alice was born in 1814 in Carrington, Cheshire, was christened on 17 Apr 1814 in Carrington, Cheshire, died on 13 Jun 1873 in Altrincham, Cheshire aged 59, and was buried on 17 Jun 1873 in Bowdon, St Mary, Cheshire.

Marriage Notes: The parish record describes both as of full age, Thomas as a farmer from Hale. Thomas's father is William, a farmer, who makes his mark. Alice is from Carrington. The marriage is registered in 3q 1838 (Altrincham 19 4; C BMD ref CE5/1/80).

Children from this marriage were:

- i. **John Warburton** was born in 1839 in Carrington, Cheshire, was christened on 7 Jul 1839 in Bowdon, St Mary, Cheshire, and died before 1841.
- ii. **Mary Warburton** was born in 1840 in Flixton, Lancashire and died before 1851.
- iii. **Ellen Warburton** was born in 1842 in Flixton, Lancashire and died after 1851.
- iv. **Alice Warburton** was born in 1844 in Flixton, Lancashire and died in 1892 in Altrincham, Cheshire aged 48.

This is one fifth (maybe more if any of his four younger siblings have died) of the proceeds from the sale of Houghs in Altrincham, and from his mother's £70 trust fund.
- Tithe: 1838, Hale Barns, Cheshire. William's farm of 104 acres in 23 fields is depicted on the Tithe Map of 1838. His landowner is Isaac Harrop. Part of his farm is now part of Hale Golf course.
- He appeared on the census in 1841 in Hale, Cheshire. Occupation farmer. Ellen, William, Josiah and Wright are living at home.
- He appeared on the census in 1851 in Hale, Cheshire. William, aged 75, is a farmer of 50 acres with 4 servants living at Ross Mill, with his wife Ann (72), plus Ellen (50) and Wright (35), and visitor William Wright (4). The drop in acreage between the 1838 tithe map and this census may be because the former is recorded standard Imperial acres while the census gives Cheshire acres.
- He appeared on the census in 1861 in Hale, Cheshire. William, aged 85, is a farmer with 3 servants living at Ross Mill. Ellen (60), Wright (44), William Wright (14) grandson occupation carter, and William (13) son of Joseph are staying.
- He signed a will in 1862 in Hale, Cheshire. His will leaves everything to his son Wright.

William married **Ann Wright** on 17 Jul 1796 in Manchester Cathedral, Lancashire. Ann was born in 1778 in Bowdon, Cheshire, was christened on 27 Sep 1778 in Bowdon, St Mary, Cheshire, died on 5 Oct 1851 in Hale, Cheshire aged 73, and was buried on 8 Oct 1851 in Bowdon, St Mary, Cheshire.

Marriage Notes: The parish record shows both to be 'of this (Manchester) parish'. William is a cordwainer. However, circumstantial evidence for this marriage being the correct one includes:

- A William Wright is staying with them in the 1851 and 1861 censuses, described as 'grandson' but he could be a grand nephew. There is no evidence for a daughter marrying a Mr Wright.
- A son is called Wright. There is no evidence of this name being used before.

- The date fits well with the birth of their first child.

General Notes: James's death was registered in 1q 1857 Altrincham 8a 131, aged 66 (on Cheshire BMD). The identification of his parents is speculative based on evidence of a couple of that name from Ashley having children baptised in the 1790s, but there is no baptism for James evident.

James married **Sarah Pickstone** on 21 Sep 1812 in Manchester Cathedral, Lancashire. Sarah was born in 1787 in Ashley, Cheshire, was christened on 7 Oct 1787 in Bowdon, St Mary, Cheshire, and died on 19 Jun 1864 in Altrincham, Cheshire aged 77.

General Notes: Sarah's baptism is not confirmed but is the closest given her age in the 1851 and 1861 censuses. She is missing from 1871. Her death was registered in 2q 1864 8a 112, aged 76 (on cheshire BMD).

Sarah married **James Davenport** on 21 Sep 1812 in Manchester Cathedral, Lancashire. James was born about 1791 in Ashley, Cheshire and died on 19 Feb 1857 in Altrincham, Cheshire aged about 66.

38. Henry Burgess, son of **Henry Burgess** and **Sarah Whitelegg**, was born in 1779 in Styal, Cheshire, was christened on 1 Jul 1779 in Hale Chapel (Unitarian), Cheshire, died in 1834 aged 55, and was buried on 14 Jun 1834 in Micklehurst, All Saints, Cheshire.

General Notes: Henry Burgess and his wife Mary had 8 children baptised at Hale Chapel. Sarah's dates fit with the Sarah who married Willaim Davenport, and her sister Elizabeth is present in the 1861 census, albeit with a slightly reduced age.

Henry is missing from the 1841 census where Mary is already living with her future husband John Perrin. The Henry Burgess of Wilmslow who was buried in 1834, aged 55, at All Saints, Micklehurst, a chapel-at-ease for Mobberley, is the best fit for Henry's death.

Henry married **Mary Roylance** on 24 Aug 1818 in Wilmslow, St Bartholemew, Cheshire. Mary was born about 1798 in Mobberley, Cheshire and died in 1859 in Styal, Cheshire aged about 61.

Marriage Notes: This marriage is the best fit for the parents of Sarah born in 1819, and is further confirmed by the fact Mary named the first son of her second marriage Thomas Roylance.

- She appeared on the census in 1841 in Styal, Cheshire. Mary Perrin (53) is living at Oversley Ford with Thomas Perrin (3), and James Perrin (3 months). These are presumably her children with John Perrin who is missing from the census. Also present are her Burgess children Mary (20), Elizabeth (15), Hannah (15), Henry (14), John (12), William (10), and Isaac (8), plus Mary Burgess (55), and Hannah Burgess (50).
- She appeared on the census in 1851 in Styal, Cheshire. Mary (53) is living at Oversley Ford with husband John Perrin (44), a farmer of 107 acres. Also present are John's sons Thomas (11), and James (10), and her children Mary (30), Elizabeth (28), Henry (24), John (22), William (20), and Isaac (17), plus lodgers Mary Burgess (69) and Hannah Burgess (66).

Mary married **Henry Burgess** on 24 Aug 1818 in Wilmslow, St Bartholemew, Cheshire. Henry was born in 1779 in Styal, Cheshire, was christened on 1 Jul 1779 in Hale Chapel (Unitarian), Cheshire, died in 1834 aged 55, and was buried on 14 Jun 1834 in Micklehurst, All Saints, Cheshire.

Mary next married **John Perrin** before 1841. John was born about 1806 in Wilmslow, Cheshire.

Marriage Notes: Mary is Mary Perrin in 1841.

- He appeared on the census in 1871 in Takeley, Essex. George (58) is an agricultural labourer living in Canfield village with Isabella (55), Moses (24), Alfred (21), Walter (19), James (16), George (15), Arthur (13), and David (9).
- He appeared on the census in 1881 in Little Canfield, Essex. George (68) is an agricultural labourer living with Isabella (63), Reuben (38), David (18), and granddaughter Annie (8).

64. John Warburton, son of **John Warburton** and **Martha Hanson**, was born in 1716 in Hale Barns, Cheshire, died on 16 Nov 1791 in Hale Barns, Cheshire aged 75, and was buried on 20 Nov 1791 in Bowdon, St Mary, Cheshire.

General Notes: John's baptism isn't in the parish records at Bowdon, suggesting a non-conformist baptism at home or at Ringway Chapel which was still controlled by dissenters.

Although he is paying rent for Easty Lane tenement his will refers to his lease from John Perrin. The will of Josiah Perrin in 1726 refers to 'my Estate lying and being in Yestow [Eastoe] Lane (formerly call'd Healds)'. Easty Lane was held on a 3 life lease on a low rent of £1 8s 10d, but the year after his death Mary is paying £26. John was the last life so it presumably reverted to a rack rent. Mary was still paying (now £28) in 1807. The lease with John Perrin expired before 1806 as the wording of his will implies it was due to occur before his youngest child, Jane, reached 21. This implies they were two separate leases but doesn't explain why Easty Lane isn't included in the will. It may have already been transferred to his wife.

He was buried in grave P492 "in his 76th year" with his first wife Sarah, and his granddaughter Mary, daughter of Joseph and Grace of Rostherne who died in 1831 aged 15. This makes his birth date 1716, or late 1715.

Noted events in his life were:

- Lease: 22 Jun 1722. John is a life on a lease taken by Isaac Falconer. This is known from the 1764 Rental and Lease abstracts which describes John as a farmer aged 46. He can only have been a boy when the lease was taken.
- Legacy: 13 May 1723. John received £20 from the will of his grandfather James Hanson.
- Legacy: 8 Apr 1729. John was bequeathed £80 in the will of his grandfather Josiah, who died in 1730. He also shared one half of the residue with his father and sister.
- Lease: 7 Nov 1746, Hale Barns, Cheshire. John is party to a lease with John Crewe of Crewe, in which he surrenders and renews the lease on Easty Lane tenement for a fine of £45 and at a rent of 22s 10d per annum. His father John remains a life on the lease and his son Thomas replaces grandfather Josiah as the 3rd life.
- Lease: 24 Feb 1751, Ringway, Cheshire. John leased land for 21 years from the following February 2nd (i.e. to 1773), at a rack rent of £12 1s per annum. This is apparently a lease renewal because the land is Oxheys, which along with Ringway meadow, Aspinnurs and Nine Butts is tenanted by John Warburton (John's father) in the 1726 Survey. Ringway meadow, Aspinnurs and Nine Butts are still tenanted by John's widow Mary in the pre 1807 survey.
- Lease: 4 Oct 1751, Hale, Cheshire. A lease on the moiety of Parker's tenement includes John as a life. This is known from the 1764 Rental and Lease abstracts where John is referred to as John senior aged 47.

Ancestors of Raymond George Warburton

- Legacy: 1756. John's father's will left him a Chief Rent of 6s 8d per annum from William Tatton of Withenshaw, his household goods (except the linen and books which were shared with his sister), and half the residue of his personal estate after various legacies were paid.
- Rental: 1764, Hale, Cheshire. The Crewe Rental with Lease Abstracts includes for John:
 - Rent of £1 8 10d on land leased on Nov 7th 1746, i.e. Easty Lane tenement. The increase over the value in the lease may cover the land in Ringway not covered by the 21 year lease below.
 - Rent of £12 1s 0d on land in Ringway leased on Feb 24th 1751 for 21 years.
- Rental: 19 Nov 1773, Ringway, Cheshire. This is first rental where the rental for Oxheys ceases. It is now rented by Peter Goodier. The refernces to Ox Hays first appears in the 1772 rental, becoming Ox Heyes in 1773.
- Rental: 1785, Hale, Cheshire. Rentals collected at Martinmas include:
 - John, for late Josiah's tenement called Yester Lane, £1 8s 10d.
 - Benjamin Whitelegg, for 1 acre, part of Parker's late held by John £1 10s 0d, and for part of Parker's leased in 1751 on lives of John of Easty Lane aged 62 (died 1791 according to later note), Joseph Faulkener, and Benjamin Whitelegg (living on premises). Benjamin is described as 'tenant at will' for the part held by John. Rental not noted. Benjamin is John's son-in-law having married his daughter Martha.
- He signed a will on 8 Nov 1791. This was proved on April 21st 1792. He mentions 2 tenements, one in Hale which he leases from John Perrin, and one in Altrincham called Houghs. Executors are Andrew Garner and George Hankinson. The will is complex to ensure the upbringing of his younger children.

John married **Sarah Johnson** on 8 Aug 1736 in Bowdon, St Mary, Cheshire. Sarah was born in 1715, died on 15 Aug 1762 aged 47, and was buried in 1762 in Bowdon, St Mary, Cheshire.

Marriage Notes: In the parish record John (Jun) is of the parish of Bowdon, Sarah of the same parish, and the wedding is by publication of Banns. The Jun(ior) must be because his father is still alive.

Children from this marriage were:

- Josiah Warburton** was born about 1737 in Hale Barns, Cheshire, died in 1738 aged about 1, and was buried on 23 Mar 1738 in Bowdon, St Mary, Cheshire.

Marriage Notes: In the parish record John is of Bowdon parish, farmer. Mary is also of Bowdon parish. They were married by license from Humphrey Owen. John signs, Mary makes her mark. William Yarwood and John Hough are witnesses.

65. Mary Hough was born in 1749, died on 17 Dec 1822 aged 73, and was buried in 1822 in Bowdon, St Mary, Cheshire.

General Notes: Mary was buried in grave P493 "aged 73", with her son Josiah, aged 10 months, and her grand parents-in-law.

Ancestors of Raymond George Warburton

Noted events in her life were:

- Rental: 1792, Hale, Cheshire. Mary's name is pencilled in over her late husband's for the rental on Easty Lane tenement of £26 per annum. This has been changed from the £1 8s 10d charged under the 3 life lease in 1785. It isn't known if the term was changed at the same time.
- Land Survey: Abt 1800, Hale, Cheshire. An undated 19th century land survey lists Mary paying rack rent for: House, barn, yard, garden, orchard, Nearer and Further Fields at Door, Sound Field, Eve's Field, Lower Eve's Field, and at Ringway, Ringway Meadow, Nine Butts and Aspinars, total almost 27 acres. Near and Further Fields at Door, Sand Field, Eve's Field, Little Eve's Field, Aspinhurst, Ringway Meadow, Half Acre and Nine Buts, plus Ox Heys and Lamb's Croft are all on the 1838 tithe map.
- Rental: 1807, Hale, Cheshire. The rental includes Mary Warburton, for Easty Lane tenement, except Ringway Meadow, Nine Butts, and Aspinars sold to Mr Egerton, £28 per annum (a further increase). The Crewes sold their Hale estates in 1808.

Mary married **John Warburton** on 7 Jan 1769 in Bowdon, St Mary, Cheshire. John was born in 1716 in Hale Barns, Cheshire, died on 16 Nov 1791 in Hale Barns, Cheshire aged 75, and was buried on 20 Nov 1791 in Bowdon, St Mary, Cheshire.

66. James Wright was born about 1740, died on 9 Dec 1821 aged about 81, and was buried in 1821 in Bowdon, St Mary, Cheshire.

General Notes: James was buried in grave 936, aged 81.

James married **Martha Wright** on 12 Oct 1766 in Lymm, Cheshire. Martha was born about 1739, died on 4 Mar 1809 aged about 70, and was buried in Bowdon, St Mary, Cheshire.

Children from this marriage were:

- i. **Ellen Wright** was born in 1770 and was christened on 9 Sep 1770 in Bowdon, St Mary, Cheshire.
- ii. **Martha Wright** was born in 1774, was christened on 7 Nov 1774 in Bowdon, St Mary, Cheshire, died on 1 Dec 1795 aged 21, and was buried in Bowdon, St Mary, Cheshire.
- iii. **Sophia Wright** was born in 1775 and was christened on 30 Jul 1775 in Bowdon, St Mary, Cheshire.

Henry married **Sarah Whitelegg** on 24 Mar 1778 in Mobberley, St Wilfred, Cheshire. Sarah was born in 1740, died on 16 Apr 1816 aged 76, and was buried in Bowdon, St Mary, Cheshire.

Ancestors of Raymond George Warburton

Children from this marriage were:

- 38 i. **Henry Burgess** (born in 1779 in Styal, Cheshire - died in 1834, buried in Micklehurst, All Saints, Cheshire)
- ii. **Mary Burgess** was born in 1781 and was christened on 30 Jun 1781 in Hale Chapel (Unitarian), Cheshire.

77. Sarah Whitelegg was born in 1740, died on 16 Apr 1816 aged 76, and was buried in Bowdon, St Mary, Cheshire.

General Notes: Sarah subsequently married Henry Burgess of Mobberley. They each received 2s 6d from her father-in-law's will. She was buried in grave P394 "aged 76 years", with her first husband Thomas and their daughter Sarah.

Sarah married **Thomas Warburton** on 3 Dec 1767 in Bowdon, St Mary, Cheshire, son of **John Warburton** and **Sarah Johnson**. Thomas was born in 1741 in Hale Barns, Cheshire, died on 28 Apr 1768 aged 27, and was buried in Bowdon, St Mary, Cheshire.

Marriage Notes: In the parish record Thomas is of Hale, husbandman, Sarah, is of the same parish, spinster. They were married by license. Both signed the register, B Whitelegg and John Warburton were witnesses.

General Notes: Thomas's baptism isn't recorded at Bowdon, so he was presumably baptised either at Hale Chapel, where records only begin in 1752, or at home.

He died intestate. His administration document granted administration of his estate to his wife Sarah and Benjamin Whitelegge brother of Sarah and husband of Thomas's sister Martha. He was buried in grave P394 "in his 27th year". His wife Sarah, who remarried to Henry Burgess of Mobberley, and his daughter, a spinster, were also buried there.

Noted events in his life were:

- Lease: 7 Nov 1746, Hale Barns, Cheshire. Is named as a life when his father renews the lease on Easty Farm tenement.

The child from this marriage was:

- i. **Sarah Warburton** was born on 3 Oct 1768, was christened on 23 Oct 1768 in Bowdon, St Mary, Cheshire, died on 23 Dec 1827 aged 59, and was buried in Bowdon, St Mary, Cheshire.

Sarah next married **Henry Burgess** on 24 Mar 1778 in Mobberley, St Wilfred, Cheshire. Henry was born in 1739 in Mobberley, Cheshire.

128. John Warburton, son of **Josiah Warburton** and **Jane Hollinpriest**, was born in 1680 in Hale Barns, Cheshire, was christened on 23 May 1680 in Bowdon, St Mary, Cheshire, died on 12 Mar 1756 in Hale Barns, Cheshire aged 76, and was buried in 1756 in Bowdon, St Mary, Cheshire.

General Notes: John was buried in grave P494 "in the 76th year of his age" with his wife Martha, and an infant Thomas who is a great grandson.

Ancestors of Raymond George Warburton

Noted events in his life were:

- Lease: 10 Jun 1708, Hale, Cheshire. John was party to a lease with William Ffrowde for a messuage in Hale lately occupied by George Parker of Dunham. The 3 lives were James Whitelegg, son of Benjamin, and George and William Parker sons of the late George. A note on the lease of the same date says 'Life added, part of Parker's, rent 13s'.
- Lease: 14 May 1719, Hale Barns, Cheshire. John was party to a 3 life lease from William and Lucy Ffrowde, the other lives being his father Josiah, and son John. This lease is known from its renewal in 1746 by his son John. It is for the land later known as Easty Lane Tenement.
- Lease: 16 May 1719, Hale, Cheshire. John was party to a lease with William Ffrowde for the late George Parker's messuage in Hale now occupied by John. The 3 lives were James Whitelegg, son of Benjamin, John, and his son John. A note on the lease says 'part of Parker's, rent 13s'.
- Legacy: 13 May 1723. John received £50 from the will of his father-in-law James Hanson. His 2 children received £20 each and John was an executor. James left over £1000 and a farm in Mobberley already in the hands of his son James. James himself was living with his daughter Sarah Leicester at the Leicester seat at Hale Low.
- Land Survey: 1726, Hale, Cheshire. A survey of the Crewe lands in Hale and Ringway shows John Warburton as tenant of:
 - 20 acres in Ringway including Ringway Meadow, Nearer and Further Oxhey, Aspinnurs, Nine Butts and Lamb Croft. These fields are identifiable on the 1838 tithe map. Although they were part of a larger farm at that time they are not contiguous, but form 3 distinct chunks.
 - 20 acres in Hale including a house, barn and orchard, Field at Door, Soon'd Field and Evers Field. These fields can be seen on the 1838 tithe map where they are part of a larger farm. They are not contiguous but form 2 separate chunks.
 - 28 acres in Hale jointly with Benjamin Whitelegg including a house, barn and orchard, Barn Field, Middle Field, Bow Croft, Hale Field, Dobb Croft, Greenhale Moor, Middle and Little Hale Moor, and Hale Moor Field. Whilst a number of these names appear on the Tithe Map they form no cohesive entity.
- Legacy: 8 Apr 1729. John was named an executor in his father's will. He also received half the residue of the estate, divided equally between himself and his two children. Josiah died in 1730.
- Event: 3 Sep 1731, Hale, Cheshire. John was taken to court by John Crewe over £80 10s owed on part of Parker's tenement and part of Hesketh's tenement. This represents rent of £11 10s unpaid for 1726-32. John Crewe repossessed the property and received £49 12s 10d costs.
- Rental: 1734, Hale, Cheshire. The Crewe Rent Books for 1734-7 show:
 - John with a rack rent of £12 0s 8d paid, probably for the land in Ringway.
 - Benjamin Whitelegg for part of Parker's; rest John Warburton 9s 3d per annum, £6 0s 6 1/2d unpaid.
 - Under Hale Old Rents £1 2s 10d per annum, £14 16s 10d unpaid. This is probably Easty Lane tenement.
- Mentioned in will: 7 Apr 1734. John of Eastoe Lane is named executor in the will of John Warburton of Hale, believed to be John Warburton of Oaklands Farm.
- Event: 2 Feb 1736, Bowdon, St Mary, Cheshire. John with John Hankinson as executors of the will of John of Hale, grant his pew in the gallery of the church to John Birch of Hale for a consideration of £12.
- He signed a will on 7 Mar 1745. The main beneficiaries are his two children. Most interesting is his reference to "that Chief Rent belong to me and due from William Tatton esq of Withenshaw Hall being the sum of six shillings and eight pence yearly", which he bequeathed to his son John together with household goods. He also bequeathed £100 to his daughter Jane Norbury, and after a couple of minor bequests he divided the rest of his personal estate between John and Jane. Son John, and son-in-law John Norbury were executors.
- Lease: 3 Oct 1746, Hale, Cheshire. John was a life on a lease taken by William Garnett.
- Lease: 7 Nov 1746, Hale Barns, Cheshire. John remains a life on the lease for Easty Lane tenement when his son John renews it for a fine of £45 and at a rent of 22s 10d per annum. His grandson Thomas replaces Josiah as the 3rd life.

John married **Martha Hanson** on 25 Dec 1712 in Mobberley, St Wilfred, Cheshire. Martha was born on 14 Sep 1688 in Mobberley, St Wilfred, Cheshire, died on 23 Apr 1719 aged 30, and was buried in 1719 in Bowdon, St Mary, Cheshire.

Children from this marriage were:

- 64 i. **John Warburton** (born in 1716 in Hale Barns, Cheshire - died on 16 Nov 1791 in Hale Barns, Cheshire)
- ii. **Jane Warburton** was born before 1719 and died after 1756.
- iii. **Josiah Warburton** was born about 1719 in Hale Barns, Cheshire, died in 1719 in Hale Barns, Cheshire, and was buried on 2 May 1719 in Bowdon, St Mary, Cheshire.

John next married **Mary**. Mary died before 1756.

Marriage Notes: The existence of Mary is only known from the bequest of one shilling in father-in-law Josiah's will. No wedding at Bowdon matches.

Martha married **John Warburton** on 25 Dec 1712 in Mobberley, St Wilfred, Cheshire. John was born in 1680 in Hale Barns, Cheshire, was christened on 23 May 1680 in Bowdon, St Mary, Cheshire, died on 12 Mar 1756 in Hale Barns, Cheshire aged 76, and was buried in 1756 in Bowdon, St Mary, Cheshire.

152. Henry Burgess, son of **Henry Burgess** and **Unknown**, was born in 1704.

Henry married **Hannah Whitelegg** on 2 Jan 1733 in Bowdon, St Mary, Cheshire. Hannah was born in 1709 and was christened on 26 Oct 1709 in Bowdon, St Mary, Cheshire.

Marriage Notes: Henry was of Mobberley parish.

The child from this marriage was:

76 i. **Henry Burgess** (born in 1739 in Mobberley, Cheshire)

153. Hannah Whitelegg, daughter of **Benjamin Whitelegg** and **Unknown**, was born in 1709 and was christened on 26 Oct 1709 in Bowdon, St Mary, Cheshire.

Hannah married **Henry Burgess** on 2 Jan 1733 in Bowdon, St Mary, Cheshire. Henry was born in 1704.

Ninth Generation (6th Great-Grandparents)

256. Josiah Warburton, son of **John Warburton** and **Margaret Hardy**, was born on 13 Mar 1658 in Hale, Cheshire, was christened on 6 Jun 1658 in Bowdon, St Mary, Cheshire, died on 20 Mar 1730 in Northen Etchells, Cheshire aged 72, and was buried on 28 Mar 1730 in Bowdon, St Mary, Cheshire.

General Notes: Josiah is thought to have remarried because of the burial of Margaret, wife of Josiah of Northenden, as this was where he was living when he died. However no marriage has been found, and she is not buried in the same grave.

The parish burial record at Bowden refers to Josiah of Northen parish buried March 28th 1729/30. He is buried in grave P493 "in the 73rd year of his age". with his wife Jane, his great great grandson Josiah (aged 10 months), and his great grand daughter-in-law. The grave has his date of death as 1729. This is on the old Julian calendar when New Year was 25th March. It is 1730 by the modern Gregorian calendar.

Josiah signed a will on 8 April 1729. The will mentions Josiah's brother John and his wife Elizabeth, showing them to be still alive when it was signed. He bequeathed:

- Twenty shillings to John Coppock; and £80 to each of his children: Bryan, William and Jane.
- To daughter Deborah Coppock's children, £80 to Josiah, and £60 to Mary (because he had provided money for the purchase of land at Crossacre which is settled upon her on her mother's death).
- One shilling to son John's wife Mary.
- To son John's children, John and Jane, £80 each.
- The interest on £10 to the poor of Hale.
- The interest on £20 to the nonconformist minister at Hale Chapel.
- Five pounds to brother John, or if dead, his wife Elizabeth.
- small amounts to good friend Wiliam Marsh (40s), Hannah Higson daughter's maid (40s) Richard Rylands daughter's man (20s), Rev Mr Worthington at Dean Row (40s), Rev Joseph Hankinson (40s).
- Twenty shillings for the poor of Etchells.
- The rest, including chattells, personal estate and Chief Rent to go one half to Deborah and one half divided amongst John and his two children.

John and Deborah were executors.

Noted events in his life were:

- Legacy: 14 Jan 1686. Josiah is bequeathed 10 shillings in his father's will. The will was proved March 21st 1692.
- Event: 5 Nov 1686, Hale, Cheshire. The first lease to name Josiah as attorney to Lady Lucy Crewe and her husband Charles Turner was on this date.
- Reference: 1693, Hale, Cheshire. R.N. Dore quotes Vicar Hyde naming him as Hale bailiff to the second wife of the late John Crewe, also as "main and chief pillar of the conventicle". Josiah's is referred to as the attorney or agent on leases between 1686 and 1722, the landlord being Lady Lucy Crewe, and her husband, first Charles Turner and later William Frowde.
- Rental: 1701, Hale, Cheshire. A Josiah Warburton is paying 8s 2d per annum rent to the Stamford estate (Dunham

Massey) for Brooks Farm, Hale, 18 acres valued at £1 10s 2d. The lease was not renewed after 1704. In Jill Groves notes the value is unknown, the rent is £1 10s 2d, and duties are 8s 2d so maybe I copied it wrongly.

- Lease: 14 May 1719, Hale Barns, Cheshire. Josiah was a life on a lease taken by his son John for a messuage in Hale Barns. This messuage is later known as Easty Lane tenement on Eastoe/Easter Lane (now part of Hale Road). The lease is known from a reference in a later lease. Josiah's grandson John is the third life on the lease.
- Event: 26 Jun 1722, Hale, Cheshire. The last lease to name Josiah as attorney to Lady Lucy Crewe and her husband William Ffrowde has this date. He appears on all the leases since 1686.
- Event: 1723. Josiah was one of the leaders in founding Hale Chapel.
- Event: 1723, Northen Etchells, Cheshire. A Josua signs the Oath of Allegiance in Etchells.
- Inventory: 30 Apr 1730, Northen Etchells, Cheshire. The inventory was appraised on April 23rd 1730 by Josiah and John Hankinson and consists of household items, including books valued at £8, and the sum of £1027 of 'money at interest'.

Josiah married **Jane Hollinpriest** on 12 Feb 1678 in Bowdon, St Mary, Cheshire. Jane was born in 1656, died on 30 Sep 1685 aged 29, and was buried in 1685 in Bowdon, St Mary, Cheshire.

Children from this marriage were:

- i. **Deborah Warburton** was born in 1678, died on 18 May 1737 aged 59, and was buried in Bowdon, St Mary, Cheshire.
- 128 ii. **John Warburton** (born in 1680 in Hale Barns, Cheshire - died on 12 Mar 1756 in Hale Barns, Cheshire)
- iii. **Margaret Warburton** was born in 1682 in Hale Barns, Cheshire, was christened on 25 May 1682 in Bowdon, St Mary, Cheshire, died on 7 Aug 1719 aged 37, and was buried in Bowdon, St Mary, Cheshire.

Josiah next married **Margaret** on 25 Dec 1711 in Bowdon, St Mary, Cheshire. Margaret was born in Northenden, Cheshire, died in 1722, and was buried on 3 Mar 1722 in Bowdon, St Mary, Cheshire.

Marriage Notes: This is a possible second wife. A Josiah married Martha Faulkener of Northenden in 1711. We know Josiah finished his life in Northenden. A Margaret Warburton, wife of Josiah, Yeoman of Northenden was buried in 1722. It would seem Martha and Margaret might be the same person.

257. Jane Hollinpriest was born in 1656, died on 30 Sep 1685 aged 29, and was buried in 1685 in Bowdon, St Mary, Cheshire.

Jane married **Josiah Warburton** on 12 Feb 1678 in Bowdon, St Mary, Cheshire. Josiah was born on 13 Mar 1658 in Hale, Cheshire, was christened on 6 Jun 1658 in Bowdon, St Mary, Cheshire, died on 20 Mar 1730 in Northen Etchells, Cheshire aged 72, and was buried on 28 Mar 1730 in Bowdon, St Mary, Cheshire.

258. James Hanson was born in Mobberley, Cheshire and died on 13 May 1723 in Hale Low, Hale, Cheshire.

General Notes: James left a will.

James married.

His child was:

- 129 i. **Martha Hanson** (born on 14 Sep 1688 in Mobberley, St Wilfred, Cheshire - died on 23 Apr 1719, buried in Bowdon, St Mary, Cheshire)

304. Henry Burgess died in 1728 and was buried on 25 Dec 1728 in Knutsford St John, Cheshire.

Henry married.

306. Benjamin Whitelegg.

Tenth Generation (7th Great-Grandparents)

512. John Warburton, son of **George Warburton** and **Sibill Perrin**, was born in 1608 in Hale, Cheshire, died on 8 Jun 1691 aged 83, and was buried on 10 Jun 1691 in Bowdon, St Mary, Cheshire.

General Notes: John is buried in grave P407, though this gravestone is probably not in its original position. He died "in his 83rd year", giving a date of birth in 1608-9.

Ancestors of Raymond George Warburton

John son of George is equated with John husband of Margaret because he is likely to have survived to 1667 when the Poll Tax was conducted (though burial records for that period seem to be missing). John son of George is definitely alive in 1662 when he and his wife receive a legacy from the estate of John Eaton. The other 2 Johns in the Hale Poll Tax record can be discounted as one is an unmarried labourer, and the other is a wheelwright who can be identified as a descendent of George's contemporary William the Elder of Hale (d. 1611) through several wills linking that family to the Johnson family. Also John and Margaret, like George, are linked to Hale Barns, specifically in the baptism records of Margaret, George and Josiah.

A John, possibly this one, performed nine appraisals of Inventories in Hale between 1663 and 1679.

The appraisal of John's mother-in-law Margaret Hardy was performed in 1664 by Henry Warburton, raising the possibility he was realated, possibly another son who had left home by 1667. However it is more likely he was the brother of John Warburton, wheelwright, whose relationship to John, if any, is unknown.

Noted events in his life were:

- Lease: 1 Nov 1617, Hale Barns, Cheshire. John is a named life on a 3 life lease taken by John Burgess for a messuage in Hale Barns. The other lives are John Burgess and his wife Sibill.
- Lease: 23 Mar 1625, Ringway, Cheshire. John is a life on a lease taken by his father for land previously occupied by Robert Letherborough sen, along with Robert jun. and Ann Hardy.
- Mentioned in will: 17 Apr 1647, Hale, Cheshire. A John, believed to be this John, was a witness to the will of Robert Hollinpriest. A John also witnessed the wills of Andrew Gardner dated Sept. 11th 1641, died 1648, and Elizabeth Goulden dated April 23rd 1649.
- Legacy: 20 May 1654, Hale, Cheshire. Wife Margaret receives bequest of £10 from her father's will, proved Sept 25th 1654 at Westminster. Children also get 6s 8d each.
- Mentioned in will: 12 Jan 1660, Hale, Cheshire. A John is executor of the will of George Goulden, Tanner, of Hale. Thomas is a witness. This is probably John and his son Thomas.
- Legacy: 23 Jan 1662, Bowdon, Cheshire. There is a bequest of 10s to John and his wife in the Inventory of John Eaton, his brother-in-law.
- Hearth tax: 1664, Hale, Cheshire. There is a reference to a John with 2 hearths.
- Poll Tax: 1667, Hale, Cheshire. Three John's are mentioned in Hale. The first is a labourer, unmarried. The second is a wheelwright and linked to William Warburton the Elder (died 1611) via a number of legacies from the Johnson and Coppock families. The third is this John. His wife and his 7 children are also listed.
- He signed a will on 14 Jan 1687 in Hale Barns, Cheshire. His wife and five sons receive bequests. There is no mention of his 2 daughters (Deborah is known to be dead). All the sons are also executors, except George (who was also not an executor on brother Enoch's will). This might imply that George did not live near, or he wasn't considered capable of performing the role.
- Inventory: 1691, Hale Barns, Cheshire. His inventory (date unclear) consists mainly of household items, farm implements and some crops in the ground valued at £88 17s 0d.

John married **Margaret Hardy**. Margaret died on 3 Oct 1696 and was buried in Bowdon, St Mary, Cheshire.

- iii. **Deborah Warburton** was born after 1641, died in 1677 in Hale, Cheshire, and was buried on 21 Sep 1677 in Bowdon, St Mary, Cheshire.
- iv. **John Warburton** was born about 1648 in Hale, Cheshire and died after 1729 in Mobberley, Cheshire.
- v. **George Warburton** was born in 1654 in Hale, Cheshire, was christened on 8 Oct 1654 in Bowdon, St Mary, Cheshire, and died after 1686.
- 256 vi. **Josiah Warburton** (born on 13 Mar 1658 in Hale, Cheshire - died on 20 Mar 1730 in Northen Etchells, Cheshire)
- vii. **Enoch Warburton** was born in 1662 in Hale, Cheshire, was christened on 16 Oct 1662 in Bowdon, St Mary, Cheshire, died in 1692 in Mobberley, Cheshire aged 30, and was buried on 2 Jul 1692 in Mobberley, St Wilfred, Cheshire.

513. Margaret Hardy, daughter of **James Hardy** and **Margaret**, died on 3 Oct 1696 and was buried in Bowdon, St Mary, Cheshire.

Ancestors of Raymond George Warburton

Noted events in her life were:

- Legacy: 2 Jan 1646, Hale, Cheshire. Henry Hardy, Margaret's uncle bequeathed monies owed to him by various parties to be divided between 4 nephews and neices, including Margaret. His inventory showed debts owing of £56 3s 5d.
- Legacy: 20 May 1654, Hale, Cheshire. Margaret receives bequest of £10 from her father's will, proved Sept 25th 1654 at Westminster. Children also get 6s 8d each.

Margaret married **John Warburton**. John was born in 1608 in Hale, Cheshire, died on 8 Jun 1691 aged 83, and was buried on 10 Jun 1691 in Bowdon, St Mary, Cheshire.

11th Generation (8th Great-Grandparents)

1024. George Warburton, son of **Thomas Warburton** and **Alice**, was born about 1575 in Cheshire, died in 1639 in Hale Barns, Cheshire aged about 64, and was buried on 24 Jun 1639 in Bowdon, St Mary, Cheshire.

General Notes: George is identified as the father of William of Northenden by the reference to John Eaton in the wills of both George and William.

George is identified as the brother-in-law of Thomas Perrin in the later's will. Either George's wife Sibill was Thomas's sister, or Thomas's wife Sibill was George's sister, or both.

The sequence of his daughters is based on the order they are mentioned in his will. Ellen is probably last because she is unmarried, not necessarily the youngest.

The 2 leases that George is a party to, and that mention John as a life, probably represent secondary ventures rather than his main land holding.

George signed a will on 6 August 1638. This will is the main evidence for the existence of his children. Five daughters, 4 sons-in-law, and 2 sons are named as beneficiaries, with John being the main heir.

Georges's Inventory was appraised on 28 June 1639 by James Hardy, John Burgess, William Ashley and George Warburton. This is probably the George of Hale who signed the Grand Remonstrance in 1642, and who appraised may wills in Hale up to 1639. No other evidence of him has been found.

The effects were valued at £304 1s 8d and included a horses, cattle (20), sheep (21), two pigs, poultry and geese, plus produce, farming equipment and spinning wheels and books. He also had a five year lease on a tacked of ground (2 closes) that was part of the tenement of John Burgess (probably the tenement on which George's son John was a life), plus a close of grass from John Duncalfe. He was also owed £40 by his son John.

Noted events in his life were:

- Lease: 1 Nov 1616, Hale Barns, Cheshire. George leased land from Sir Baptist Hicks, formally occupied by widows Elizabeth Antrobus and Alice Holt. The lease is 99 years or 3 lives (sons William and Thomas, and William Barrett). Elizabeth Antrobus' husband John's will in 1612 makes a bequest to William and Margaret Barrett. Therefore William Barrett is already linked to the property. This is possibly the William Barrett who was a Civil War preacher at Ringway chapel.
- Lease: 1 Nov 1617, Hale Barns, Cheshire. John son of George Warburton is a life on a lease taken by George Burgess.
- Mentioned in will: 6 Feb 1624, Hale, Cheshire. George is mentioned in the Nuncupative will of Thomas Perrin. He heard the deceased's wishes, is described as his brother-in-law, and is named executor. He made his mark.
- Lease: 23 Mar 1625, Ringway, Cheshire. George leased land from Sir Baptist Hicks in Ringway formerly leased by Robert Leatherborough (Leatherbarrow). It is a 99 year lease with 3 lives (son John, Robert Leatherborough jnr. and Ann Hardy). George's son John later married Margaret Hardy, but her relationship to Ann is uncertain.
- Accounts: 8 May 1628, Bowdon, Cheshire. Accounts of Sibell Eaton formally Barrington - daughter, These accounts include references to a payment due by George Warburton dependant upon the death of Thomas Warburton, and a claim by George against John Barrington's estate.

George married **Sibill Perrin**. Sibill was born in Hale, Cheshire, died in 1653, and was buried on 27 Oct 1653 in Bowdon, St Mary, Cheshire.

Children from this marriage were:

- i. **Sibill Warburton** was born about 1600 in Hale, Cheshire and died after 1667.
- ii. **William Warburton** was born about 1600 in Hale, Cheshire and died in Jul 1639 in Northenden, Cheshire aged about 39.
- iii. **Jane Warburton** was born in 1601 in Hale, Cheshire and died after 1639.

Ancestors of Raymond George Warburton

- iv. **Anne Warburton** was born about 1603 in Hale, Cheshire and died after 1639.
- v. **Margaret Warburton** was born about 1605 in Hale, Cheshire and died after 1639.
- vi. **Thomas Warburton** was born about 1605 in Hale, Cheshire and died before 1639 in Hale, Cheshire.
- 512 vii. **John Warburton** (born in 1608 in Hale, Cheshire - died on 8 Jun 1691, buried in Bowdon, St Mary, Cheshire)
- viii. **Ellen Warburton** was born about 1610 in Hale, Cheshire and died after 1639.

1025. Sibill Perrin was born in Hale, Cheshire, died in 1653, and was buried on 27 Oct 1653 in Bowdon, St Mary, Cheshire.

Noted events in her life were:

- Mentioned in will: 4 Jul 1639, Northenden, Cheshire. Sibill is said to be in joint possession of Hill Top house tenement in Hale with her son William.
- Rental: Abt 1644, Hale, Cheshire. Rent Roll, Sibill is named as a tenant on an undated rent roll from the reign of Charles 1. This might be the land leased in 1616, though since all the known leases George was involved with included non-family lives, it is possible they were additional to his main holding.

Sibill married **George Warburton**. George was born about 1575 in Cheshire, died in 1639 in Hale Barns, Cheshire aged about 64, and was buried on 24 Jun 1639 in Bowdon, St Mary, Cheshire.

1026. James Hardy died in 1654 and was buried on 26 May 1654 in Bowdon, St Mary, Cheshire.

James married **Margaret**. Margaret died in 1664 and was buried on 10 Mar 1664 in Bowdon, St Mary, Cheshire.

The child from this marriage was:

- 513 i. **Margaret Hardy** (died on 3 Oct 1696, buried in Bowdon, St Mary, Cheshire)

1027. Margaret died in 1664 and was buried on 10 Mar 1664 in Bowdon, St Mary, Cheshire.

Margaret married **James Hardy**. James died in 1654 and was buried on 26 May 1654 in Bowdon, St Mary, Cheshire.

12th Generation (9th Great-Grandparents)

2048. Thomas Warburton was born about 1550, died in 1635 aged about 85, and was buried on 14 Jan 1635 in Bowdon, St Mary, Cheshire.

General Notes: The evidence for believing Thomas might be George's father is as follows:

The reference in Sibil Eaton's accounts of 1628 to 'certain articles that George Warburton shall pay unto George Birch and George Burgess £20 within six months next after the decease of Thomas Warburton, which Thomas is still living', implies a link between a George and a Thomas. Although there is evidence of 3 George's in Bowdon parish at this time (2 of them in Hale), the further reference to George taking action for a debt adds to the view that Sibil's marriage portion to her deceased first husband John Barrington may be involved. Also the dependence on Thomas's death implies an expected inheritance.

George is linked to George Burgess in a lease from 1617 where George Burgess is the tenant, and George's son John Warburton is a named life. In George's will he is leasing land from George Burgess. In Thomas's Inventory he has a lease from William Dunclafe, and George in his Inventory has a close from John Dunclafe. The relationship between William and John Dunclafe is not yet known.

Finally Thomas and George are both linked to Hale Barnes.

Since George's children are born from around 1600 onwards his birth must be before 1580 (say 1575), so Thomas must have been born around 1550, making him in his 80's at death.

Noted events in his life were:

- Mentioned in will: 1604, Hale Barns, Cheshire. He was an overseer and witness to the will of Robert Barlow, who died in 1611. Thomas is described as 'of Hale Barns'.
- Mentioned in will: 1624, Hale, Cheshire. He and Thomas the younger are witnesses to Richard Grantham's will. Thomas the Younger might be a brother of George's, or maybe his son, Thomas's nephew. There is no other evidence of Thomas the Younger so he is presumed to have died without issue.
- Inventory: 20 Jan 1635, Hale, Cheshire. Thomas's Inventory is appraised by James Hardy, William Hardy, James Coe and John Litherland. His effects were valued at £98 9s 6d and included horses (2), cattle (6), sheep (6), a pig, poultry (7) and geese (4), plus produce, farming equipment and a spinning wheel. He also had a four year lease on a tacke of ground (half a close) from William Dunclafe. The date is given as 1634 on the Inventory because prior to 1752 New Year was

towards the end of March. By convention this date is normally rendered as 1634/5, but in this tree all such dates are only rendered according to the modern calendar.

Thomas married **Alice**. Alice died in 1650 in Hale, Cheshire and was buried on 13 Jun 1650 in Bowdon, St Mary, Cheshire.

The child from this marriage was:

1024 i. **George Warburton** (born about 1575 in Cheshire - died in 1639 in Hale Barns, Cheshire)

2049. Alice died in 1650 in Hale, Cheshire and was buried on 13 Jun 1650 in Bowdon, St Mary, Cheshire.

General Notes: The identification of Thomas's wife as Alice is based on Norman Warburton's book in which he details Thomas's Inventory and refers to his widow Alice. I don't have this reference on my copy of the Inventory but have yet to check the original.

Given that if Thomas is George's father he probably died in his 80's, a widow would probably be a second wife, and not the mother of George. There is no direct evidence that the Alice buried in 1650 is this one, but it's the only likely one on record.

Alice married **Thomas Warburton**. Thomas was born about 1550, died in 1635 aged about 85, and was buried on 14 Jan 1635 in Bowdon, St Mary, Cheshire.
