William Betham (1779-1853)

Sir William Betham (1779–1853) was an English-born Irish Herald and antiquarian who held the office of Ulster King of Arms from 1820 until his death in 1853. He had previously served as the Deputy Ulster Herald from 1807 to 1820. He was knighted in 1812.

Betham was born at Stradbroke in Suffolk on 22 May 1779, the eldest son of Rev. William Betham (1749–1839) a clergyman and antiquarian, and author of a five volume work on the history of the English Baronets.

Betham made genealogical notes from virtually all of the prerogative wills of Ireland from 1536–1800 and formed them into pedigree charts. He worked on these will pedigrees for eighteen years, from 30 November 1808 until 21 October 1826. Most of the prerogative wills of Ireland were later destroyed in the fire at the Public Records Office at Four Courts in Dublin during the Irish Civil War on 13 April 1922. Betham's work provided a valuable substitute for these lost records.

Betham's original notebooks are now in the National Archives of Ireland and the Genealogical Office in Dublin has his sketch pedigrees based on his will abstracts.

Abstracts from Betham's own notebooks are now published online on FindMyPast. There are over 400,000 genealogical abstracts for wills up to 1800, and marriage licenses to 1813. A search for Warburton on FindMyPast produces 12 hits from the Prerogative Licenses Abstracts, and 218 hits from the Genealogical Abstracts. This document is a catalogue of those entries.

As some marriages are from the Genealogical Abstracts, and one entry from the Prerogative Licenses Abstracts is an Administration I have produced a combined list in date order. Index entries are ignored, and several hits may refer to the same document. Also a number of events were covered twice, possibly due to the collection of Warburton events together to aid the drawing of genealogical pedigrees.

The various events include wills, administrations (admons), marriage licenses, an occasional parish record, and some miscellaneous notes. The are also a number of hand drawn trees that are collected into a separate section at the end. The first 4 wills are English wills and it is not clear what their relevance is to Ireland. It is possible they had land in Ireland, but this seems unlikely for 2 husbandmen and a widow from Carrington.

I believe most of the entries will relate to members of the Garryhinch clan. Exceptions might include members of the Mongon clan post 1792, and servicemen on postings in Ireland. However it hasn't been possible to link all the entries to the Garryhinch clan.

Dates are placed at the beginning of entries although they are usually within the text in the original.

This tree is the Hefferston Grange branch of the Arley Tree but no children of William and Ann nee Warburton are shown in that tree. Whilst it is likely these children existed, Betham's association of William junior with the cavalier buried at Shelton, Notts, and Richard with Richard of Ireland are unlikely. William's association with Shelton Manor ties him more closely with Ann, daughter of Sir John Warburton and Mary Brereton as Shelton Manor formed part of her marriage settlement. The available evidence on Richard of Ireland indicates he was an established businessman by 1631, and probably by 1627, and this makes him too old to be the son of William, whose father's will indicates he was born no earlier than 1593.10

This tree references Ralph Bigland (1712-84) an antiquarian and Norroy King at Arms, as both the source of the tree, and the subsequent disclaimer to its truth. It shows that Anne, the mother of Rev. Charles Mongan, who took the name Warburton in 1792, was herself a Warburton before her marriage.

However the London Gazette entry announcing the change of name refers to it only as the name of Charles's maternal cousins, and not his mother's maiden name. It seems likely that it was Anne's unidentified sister who married a Warburton and produced Charles's Warburton cousins.

The pedigree also suggests that Charles's cousins were descended from John, son of Richard of Dublin, being the children of his son William. Indeed a son of John 's would fit a reference to "cousin William of London" in the will of his cousin Richard

who died in 1746. However 'cousin' could cover a cousin once removed, and Richard did have a cousin Richard who had a son William who was living in London around the time of Richard's will.

Therefore, given that William is not mentioned in the wills of his father, mother or brother, he probably didn't exist.
